

RE: ELECTIONS IEU-TCEE BRANCH 2005

As Secretary of the Independent Education Union TCEE Branch and the Tasmanian Catholic Education Employees Association, I am required by Section 138 Prescribed information for election (RAO Schedule, 2189 (1) of the Workplace Relations (Registration and Accountability of Organisations) to lodge the following information in respect of elections for positions in our organization required by our rules for the year 2005.

- 1. (a) The office/s in respect of which the elections are required are:
 - 1 Branch President
 - 1 Branch Vice President
 - 1 Branch Secretary/Treasurer
 - 7 Branch Committee of Management Members
 - 1 Branch Delegate to Federal Council
 - (b) The reason for the election is that the term of office is due to expire in the normal course of events.
 - (c) Upon election of the officers as detailed in (a) above for the Independent Education Union Tasmanian Catholic Education Employees Branch, the same officers for the same positions take office for the Tasmanian Catholic Education Employees Association.
 - (d) The electorate comprises only members of the Independent Education Union Tasmanian Catholic Education employees (TCEE) Branch.
 - (e) Nominations called for from Monday the 15th August 2005 until Monday September 5th 2005 or such later dates as the Australian Electoral Office may advise.

- (f) I propose that the day on which the roll of voters will be closed will be Monday 8th August 2005 or such later date that the Australian Electoral Office may advise.
- (g) Elections shall be by secret ballot using a direct voting system by preferential voting.
- 2. I hereby state that I, Christopher Gerard Smallbane being the Secretary of the Independent Education Union TCEE Branch, am the duly authorised officer to lodge the above information under subsection 189 (1) of the RAO Schedule.
