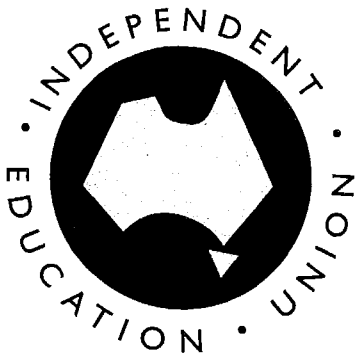

STATEMENT CONCERNING NUMBER OF MEMBERS

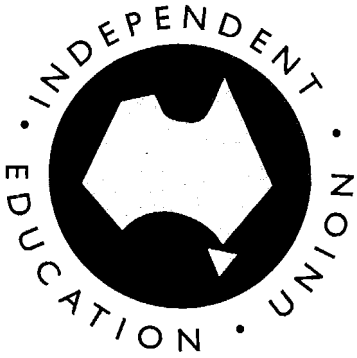


