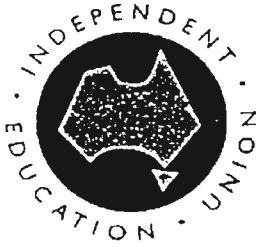
CERTIFICATE

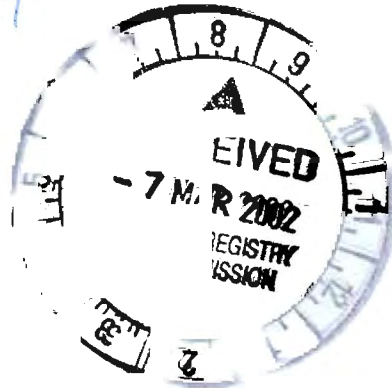
