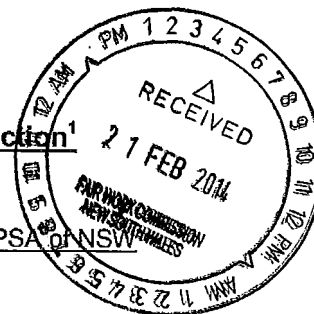

Notice and Statement of Prescribed Information for an Election¹



I, Blake Stephens, being the nominated person of the Industrial Staff Union - PSA of NSW, make the following statement:

I am the nominated person of the Industrial Staff Union - PSA of NSW,

I am authorised to lodge the following prescribed information concerning forthcoming elections in the Industrial Staff Union - PSA of NSW, and

I confirm that the following information is being lodged under subsection 189(1) of the *Fair Work (Registered Organisations) Act 2009*.

A General Meeting of the ISU members was held on the 10 February 2014. 24 members attended, being above the quorum of 7 members as required for a general meeting. See Rule 12 (3).

This meeting approved the following motion.

This meeting of the ISU (being the Industrial Staff Union PSA of NSW as registered with the Fair Work Commission) authorise Blake Stephens to call an election for the Management Committee, and liaise with the Australian Electoral Commission to conduct the elections.

Reasons for election:

- Election for the office marked C is required because this is a new position that has been created under the rules. PLEASE NOTE: These are new positions due to the organisation gaining registration on the 17 February 2014.

Elected by:

- The electorate is the whole of the Union [Rules 14(2) and 14(5)]

Nominations open:

- On the 21 April 2014 [Rule 14(2)]

Nominations close:

- On the 12 noon, 30 April 2014 [Rule 14(3)]

Cut off date for roll:

- Shall be 7 April 2014 [Rule 14(2)]

Note:

The above sample Notice and Statement would satisfy each of the particulars required under s.189(1) and the relevant regulations.

Make sure the declaration is adjusted as appropriate to reflect the facts.

The Notice and Statement are required to be lodged at least 2 months before the first day of nominations as set out in the rules of the organisation – the General Manager of the Fair Work Commission may allow for a later day (see subsection 189(2) and regulations).

The requirement to lodge election information under s.189(2) is a civil penalty provision (see s.305).
