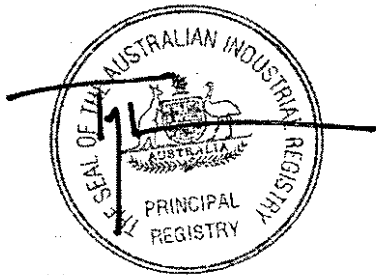

3. The electorate/s for the election/s are:


**Southern Region and North Western Region.**
