### Election For Office of President and Vice President – Master Grocers Association of Victoria ("MGAV")

As an Organisation registered under the *Workplace Relations Act 1996* (the "Act") we hereby request that arrangements be made for the conduct of an election by the Australian Electoral Commission under s 189 of *Schedule 1B (Registration and Accountability of Organisations)* of the Act ("RAO Schedule").

We furnish the following information under Regulation 138 of the *Workplace Relations (Registration and Accountability of Organisations) Regulations*:

- a) An election is required for the position of President and Vice President of the MGAV under clause 24 of its rules.
- b) The reason for the election is that the office of the President and Vice President has expired in the normal course of events under clause 24.3 of the rules.
- c) An election is required for the office of President and Vice President
- d) Under clause 24.6 of the rules notice that nominations are required for the election of a President and Vice President must be sent to each Director by the returning officer seven days after the AGM. I have contacted the AEC who have in turn referred me to your office. The annual general meeting ("AGM") of the MGAV was held on November 19 2003.
- e) Nominations open within 7 days of the AGM, and close 14 days from the date of the Notice.
- f) A direct voting system is used in the conduct of an election.

We attach a statement under s 189(2) of the RAO Schedule that the above information is lodged under s 189(1) of the said Schedule. Do not hesitate to contact the undersigned should you require any further information.
