Election for Offices - Master Grocers Association of Victoria ("MGAV")

As an Organisation registered under the *Registration and Accountability of Organisations Schedule* (the *"RAO Schedule"*) we hereby request that arrangements be made for the conduct of an election by the Australian Electoral Commission under s 189 of the said *RAO Schedule*.

We furnish the following information under Regulation 138 of the Workplace Relations (Registration and Accountability of Organisations) Regulations:

- a) An election is required for the offices of directors of the MGAV under clause 21 of its rules.
- b) The reason for the election is that the office of the directors is due to expire in the normal course of events under clause 21.6 of the rules.
- c) An election is required for the offices of three (3) directors.
- d) Under clause 21.19 of the rules, notice that nominations are required for the election of a director, must be sent to each member by the returning officer at least 72 days before the annual general meeting. The annual general meeting ("AGM") of the MGAV must be held no earlier than 31 August 2003 and no later than 30 November 2003 under clause 20.1 of the rules. The returning officer must receive nominations for the offices of directors no later than 5pm 21 days after the electoral officer under clause 21.24 of the constitution sent nomination forms to members. At this stage the AGM is planned for a date in November depending on arrangements for a timeframe with the AEC.
- e) The rules do not provide for a day on which the roll of voters is to be closed. Under the rules ballot papers are posted to members (clauses 25.5 and 25.8) and the closing date for the ballot shall be determined by the electoral officer which shall not be later than noon on the second day before the AGM.
- f) A direct voting system is used in the conduct of an election.

We also request that arrangements be made for the conduct of a further election for the positions of President and Vice President by the Australian Electoral Commission under s 189 of the *RAO Schedule*. Under clause 24.2 of the MGAV rules, the board ("officers") of the MGAV, must annually elect from their ranks a President and a Vice President. Notice that nominations are required for the offices of President and Vice President shall be sent by the returning officer to each Director no more than seven days after each AGM. Such notice shall state a closing date for nominations which will be no more than
