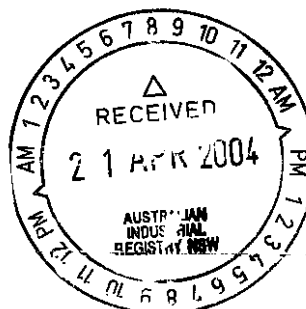


Elections of Honorary positions are held on an annual basis in accordance with the Association's rules and are conducted for by Australian Electoral Commission.
