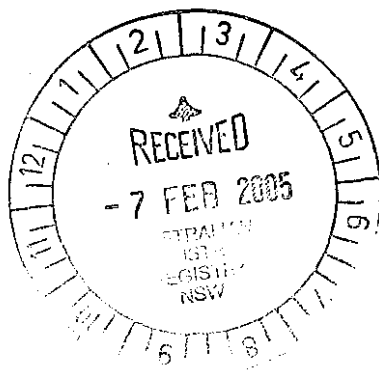

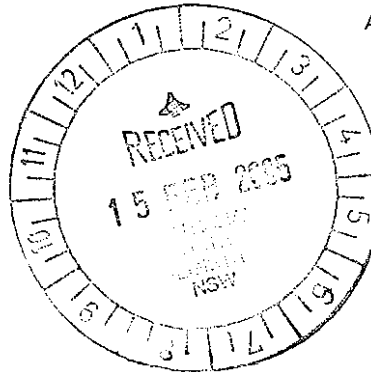


Elections of Honorary positions are held on an annual basis in accordance with the Association's rules and are conducted by the Australian Electoral Commission.

- Annual Return Of Information Contained In Records Kept By Organisation

I have received your declaration letter dated 3 February 2005 providing information in accordance with section 233 of Schedule 1B of the *Workplace Relations Act 1996*. The documents were lodged in the Industrial Registry on 7 February 2005.

The information lodged is insufficient in the following regard:

- The documents lodged failed to include the number of members as at 31/12/ 2004 as required under Reg 147(f) of WR (Registration and Accountability of Organisations) Regulations 2003.
- The documents lodged did not include a statement under cover of a declaration listing any offices for which elections must be held according to your organisation's rules during the year commencing 1 January 2005 . You are reminded that such a statement is required under s233(b) and regulation 147(e) of *Schedule 1B of the Workplace Relations Act 1996* if any elections are due during that period.
- You will be aware that the *Workplace Relations Act 1996* has been amended so that The Registration and Accountability of Organisations Schedule (Schedule 1B to the *Workplace Relations Act 1996*) [the **RAO Schedule**]. In particular - Fact Sheet No. 05/2003 7 May 2003, Australian Industrial Registry **Records to be kept and lodged by organisations**, identifies changes to the keeping and reporting of information. For example the relevant legislation is now ss233(1)(a) and (b) rather than ss268(3)(a) and (b) as referred to in your declaration.

You are therefore requested to lodge further information under cover of a declaration in the Registry at your earliest convenience.
