**Re: Annual Return of Information Contained in Records Kept by Organisation –
Master Painters Australia - N.S.W. Association Inc. (AR2006/333)**

I am writing to remind you of your obligations under s233 of Schedule 1B of the *Workplace Relations Act 1996* ('the RAO Schedule'). This section requires the organisation to lodge:

- (1) a *declaration* signed by you or other prescribed officer certifying that the register of members has been kept and maintained as required by paragraph 230(1)(a) and subsection 230(2) during 2005.
- (2) a copy of the *list of offices* in the organisation and its branches (if any).
- (3) a copy of the *names, postal addresses and occupations* of the persons holding such offices.
- (4) a list of the *names of each branch* (if the organisation has any).
- (5) a record of the *name of any branch which commenced or ceased operation* during 2005 (if applicable).
- (6) a record of the *addresses of the national, regional, divisional and/or branch offices* of the organisation (as applicable).
- (7) a record of *any election which must be held during 2006* under the rules of the organisation (if none, state so).
- (8) a record of the *number of members* of the organisation as at 31 December 2005.
- (9) a record of the number of any members who were ineligible State members within the meaning of s150 (only if the organisation has entered into a s151(1) agreement).
- (10) a *declaration* signed by you or other prescribed officer that the preceding copies of information being lodged are correct statements of the information contained in the organisation's records

RAO Regulation 149 requires this information to be lodged by 31 March 2006. If you have not yet taken steps to prepare and collate the necessary information you should do so now.


