Re: Master Painters Australia - N.S.W. Association Inc.
Annual Return of Information Contained in Records Kept by Organisation

I am writing to remind you of your obligations under section 233 of Schedule 1 of the *Workplace Relations Act 1996* (the RA() Schedule). This section requires the organisation to lodge the following:

- (1) a declaration signed by you or other prescribed officer certifying that the register of members has been kept and maintained as required by paragraph 230(1)(a) and subsection 230(2) during 2006.
- (2) a copy of the list of offices in the organisation and its branches (if any).
- (3) a copy of the names, postal addresses and occupations of the persons holding such offices.
- (4) a list of the names of each branch (if the organisation has any).
- (5) a record of the name of any branch which commenced or ceased operation during 2006 (if
- (6) a record of the addresses of the national, regional, divisional and/or branch offices of the organisation (as applicable).
- (7) a record of any election which must be held during 2007 under the rules of the organisation (if none, state so).
- (8) a record of the number of members of the organisation as at 31 December 2006.
- (9) a record of the number of any members who were ineligible State members within the meaning of s.150 (only if the organisation has entered into a s.151(1) agreement).

(10) a declaration signed by you or other prescribed officer that the preceding copies of information being lodged are correct statements of the information contained in the organisation's records

Regulation 149 of the Workplace Relations (Registration and Accountability of Organisations) Regulations 2003 required this information to have been lodged by **31 March 2007**.

You should note that failure to comply with this obligation is subject to a civil penalty provision under section 305 of the RAO Schedule.

Re: Annual Return of Information Contained In Records Kept By Organisation – Master Painters Australia – NSW Association Inc. (AR2007/389)

The Registry has received your declaration dated 1 February 2007 providing information in accordance with subsection 233 of Schedule 1 of the *Workplace Relations Act 1996*. The document was lodged in the Industrial Registry on 9 February 2007.

The document lodged covers the following information:

- Number of members and employees as at 31 December 2006.
- Declaration that the register of members was maintained as required by s230.
- List of offices of the organisation and its branches and of the persons holding those offices.
- The addresses of the offices of the organisation and its branches.
- A statement regarding the elections which must be held under the organisation's rules during 2006.

Theses documents meet the requirements of the RAO Schedule.

However, the document lodged does not include a declaration, I draw you attention to section 233(2) of Schedule 1B of the Workplace Relations Act 1996 which states:

"(2) An organisation must, within the prescribed period, lodge in the Industrial Registry notification of any change made to the records required to be kept under paragraphs 230(1)(b), (c) and (d), certified by declaration signed by the secretary or other prescribed officer of the organisation to be a correct statement of the changes made."

To properly comply with the legislation, the Association should lodge a notification which includes a declaration, "the notification is a correct statement of the changes made".

All future notifications should also comply with this requirement
