Thank you for your post election report for the Media, Entertainment & Arts Alliance (E2012/400) received on 8 May 2013. I am writing to address your concerns about rules that are difficult to apply/interpret. Your report states:

The provisions of *Rule 79* (c) 5 and (k) 2 (3) (ii) are difficult to interpret and apply. It requires at least four women are elected to offices of President and Vice-Presidents and that candidates for these offices should come from a minimum of four States. To satisfy the requirements of this rule a candidate may have to be declared elected to an office regardless of the ballot results.

This rule exists to ensure that there is adequate state and gender representation in the offices of President and Vice-Presidents and, so, for the Federal Management Committee. The rule also provides the manner in which the rule should be implemented (ie in the vice-president count, if not already met) and also determines that the provision for women representation should be applied before the provisions for geographic representation.

It is not clear from your comments how the rule is difficult to apply or interpret. However, we propose that in future elections a clarifying paragraph be included in the official notice.

Thank you for your post election report for the Media, Entertainment & Arts Alliance (E2012/400) received on 8 May 2013. I am writing to address your concerns about rules that are difficult to apply/interpret. Your report states:

The provisions of *Rule 79* (c) 5 and (k) 2 (3) (ii) are difficult to interpret and apply. It requires at least four women are elected to offices of President and Vice-Presidents and that candidates for these offices should come from a minimum of four States. To satisfy the requirements of this rule a candidate may have to be declared elected to an office regardless of the ballot results.

This rule exists to ensure that there is adequate state and gender representation in the offices of President and Vice-Presidents and, so, for the Federal Management Committee. The rule also provides the manner in which the rule should be implemented (ie in the vice-president count, if not already met) and also determines that the provision for women representation should be applied before the provisions for geographic representation.

It is not clear from your comments how the rule is difficult to apply or interpret. However, we propose that in future elections a clarifying paragraph be included in the official notice.

Arrangement for conduct of election.

- [1] On 1 November 2012, the Media, Entertainment and Arts Alliance ('the organisation') lodged with Fair Work Australia prescribed information in relation to an election for various offices.
- [2] On 8 November 2012, the organisation lodged amended prescribed information and supplementary correspondence, including a request for an extension of time for lodgement later than the prescribed day. The organisation indicated that the reason for late lodgement was that in July 2012 it decided to make various rule alterations affecting the offices to be elected and apply to have them certified prior to the election process. The organisation indicated that in view of some uncertainty about the length of time that would elapse before the alterations could be made by its Federal Council and before they could be certified, it had tentatively foreshadowed that nominations would be able to open in late October 2012. Calculated from the day in late October 2012 foreshadowed to be the day on which nominations opened, the prescribed day would have been in late August 2012.
- [3] The correct prescribed information could not be finalised until after the rule alterations affecting the offices to be elected had been made and subsequently certified. The ballot for passing the rule alterations by Federal Council meeting was not concluded until 27 September 2012. The rule alterations in their final form were only lodged with Fair Work Australia on 12 October 2012 and only certified on 31 October 2012.
- [4] It is clear that from late August onwards, the organisation was never going to be in a position to meet its foreshadowed timeframe and lodge on or before the prescribed day, and in the final event it only lodged the prescribed information on 8 November 2012. It is for this reason that the organisation has requested that I allow an extension of time for the lodgment of the prescribed information.
- [5] As a consequence of the decision by the organisation to amend its rules which effected the positions which were to be subject to this election, I am satisfied that the prescribed information which reflected the relevant rule alterations could not have been lodged earlier than the day on which it was, and I allow an extension of time for lodgement up till the date on which the prescribed information was lodged.
- [6] The amended prescribed information was for the offices as listed in Attachment A.

[7] I am satisfied that an election for the offices listed in Attachment A is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election of those offices by the Australian Electoral Commission.

I am writing to advise that as per the Rules of the Media, Entertainment & Arts Alliance, an election required for certain positions, including honorary officials. My statement as required under the Fair Work Act is enclosed.

We request that you make arrangements for an election to be conducted as per our Rule 79.

I would like to request an extension of time for lodgement of the prescribed information later than the prescribed day. The election application was delayed due to a decision made by Federal Council to make alterations to the rules that affected positions for election. If no rule alterations had been proposed that affected elected positions, the election notice would have been submitted at an earlier date. It was not possible to request an election prior to the Federal Council meeting, which had a direct impact on the earliest time when lodgement of the election notice could occur.

The imprecision of the proposed date for nominations opening: ie "early October" was due to the uncertainty surrounding the length of time required to have amendments to the rules certified. At their meeting on 30 July 2012, the Federal Management Committee was hopeful that the rule amendments would be made before the "end of October 2012". However, as the rule amendments were only certified on 31 October 2012, the timetable requires alteration.

I wish to submit the following points of clarification:

- That the 12 members of the Stunt Committee are properly considered "officers".
- That the abolition of the Professional Sports Branch was endorsed by Federal Executive on 5 May 2008, and ratified by Federal Council on 27 & 28 November 2009. (minutes can be provided upon request).
- That the Federal Management Committee received advice by relevant branches concerning their respective branch structures and positions to be elected, in accordance with either rule 19(c)(1) or 19(c)(2), and determined accordingly on 25 October 2012.
- That under rule 80, the formula determining the number of delegates to Federal Council has been applied (Attachment A).

• That rule 40(c) operates in place of the relevant sub-rule in 40(b) in cases where a branch has been approved to operate.

After examining the application, and further to our discussion, I have a number of questions or comments which I think will be best addressed in the following way. Please disregard earlier versions of this email.

The prescribed information statement should be re-lodged with the following amendments as necessary:

- (1) (a) an amended statement at point 2 that includes the explicit statement that the reason for the election is the expiry of the terms of office, in order to comply with regulation 138(1)(b)(i). Thus the statement should read something to the effect that "an election for the following offices and/or positions is required under rule 79 and due to the expiry of the terms of office"
  - (b) an amended opening statement at the head of the prescribed information that makes a specific reference that the information is being provided pursuant to section 189(1) of the Act and not under section 230(1)(d), in order to comply with regulation 138(2).
  - (c) an additional statement that identifies the "day provided for in the rules of the organisation as the day on which the roll of voters is to be closed" in order to comply with regulation 138(1)f).
- the inclusion of any offices required under rule 19 and 40 for the Professional Sports Branch if it still exists. I note that no offices were elected for the Professional Sports Branch in E2010/2612 in 2010 but the question naturally arises whilseoever the reference in rule 40(b)(vii) remains. Rule 18(b) appears to require an approval of the Branch Council or a 75% vote by Federal Council before a Branch can be dissolved. I therefore request your advice as to whether this occurred or whether the status of the Branch is determined by other considerations than this rule etc.
- (3) the correct calculation of minimum women for the offices of Federal Council Delegates (Media Section) (I believe it should be 7, not 5) and (Actors Equity) Section (I believe it should be 6, not 5);
- the correct names of "Actors Equity" section and "ATAEA" section in place of "Equity" and "ECS" wherever they appear.

Supplementary material should be provided that should include:

- (a) a written request for extension of time for lodgement of the prescribed information later than the prescribed day, with reasons which would be encompassed by answers to the questions I forwarded to you by email earlier today;
- (b) clarification of whether the 12 members of the National Stunt Committee are properly considered "officers" within the meaning of section 9 of the Act or are

subordinate positions. There has not been any question over this that I can readily identify in recent past elections, but the question did occur to me upon a re-reading of rule 70A. If the National Stunt Committee is considered by the organisation as a committee or decision-making body with characteristics within the scope of the definition of "office" in section 9, no further action will be necessary, but if the organisation considers that it does not and essentially constitutes a subordinate, non-autonomous and purely advisory committee in relation to the Federal Council, then the organisation will have to make a written request to the Australian Electoral Commission under section 187 for the to conduct the election for those 12 positions at the same time and lodge a copy of that request with FWA.

- (c) confirmation of the determinations by Federal Council that each of the Branches listed are organised under rule 19(c)(1) or 19(c)(2) for the purposes of these elections;
- (d) confirmation of the numbers for each section and the basis for calculation for the purposes of delegates to Federal Council and Branch Officers.
- (e) clarification as to whether rule 40(b)(iv) and 40(b)(v) operate in addition to rules 40(b)(iii) or are superseded by rule 40(c).
