STATUTORY DECLARATION

1. THAT I am the Federal Secretary of the Media, Entertainment & Arts Alliance, an organisation of employees registered as such under the provisions of the Industrial Relations Act 1988 and I am authorised to make this declaration.
2. THAT at the time of amalgamation, 18 May 1992, central funding - placing the management and control of the assets of the organisation (including the Branches of the organisation) with the Federal Council of the organisation took effect.
