

Notification of changes made to the records [AR2014/106]**

I acknowledge receipt on 2 July 2014 of Notification of Change of office holders for The Motor Trade Association of South Australia Incorporated (MTASA).

This information clashes with the rules of the MTASA and so cannot be accepted at this time.

Rule 42(f): If on the closing of nominations the number of candidates does not exceed the number of vacancies to be filled, no vote shall be taken and the candidates or candidate as the case may be shall be declared elected by the Returning Officer **at the annual general meeting**. (my emphasis)

Mr Polley cannot be deemed to be elected to both offices until the annual general meeting (scheduled for 15 July 2014) and therefore cannot resign until that date.

At that point a new declaration signed by either the new President Frank Agostino or the Past President Neville Gibb should be made and lodged with the Fair Work Commission.

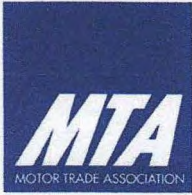
I note the reference to rule 43(j) in the information about the change. Rule 43 relates to "ballots required for the election of officers". In this instance a ballot was not required and so it is not clear that 43(j) has any application.

The MTASA may wish to consider the inclusion of rules to:

- explicitly prohibit holding more than one office at the same time; and
- provide a hierarchy of offices such that election to one office voids the nomination to a lower office.



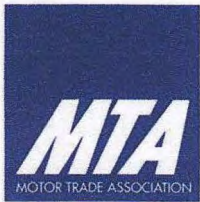

3. Your declaration must include information of each election that must, under the rules of the organisation, be held during the year commencing 1 January. This declaration doesn't include any references to elections.
4. Your declaration must indicate whether the organisation has entered into an agreement under section 151(1) of the Act with a state association and if so the number of members of the state union who were not eligible to be members of the organisation on 31 December in the previous year. This may be "The organisation has not entered into any s.151(1) agreements."
