Fair Work (Registered Organisations) Act 2009 s.189—Arrangement for conduct of an election

# The Motor Trade Association of South Australia Incorporated (E2020/45)

Arrangement for conduct of election.

[1] On 6 May 2020 the Motor Trade Association of South Australia Incorporated (**the Association**) lodged with the Registered Organisations Commission prescribed information for an election to fill the following offices:

Board Members	(7)
Chair	(1)
Deputy Chair	(1)

- [2] On 12 May 2020 a decision was issued by a Delegate of the Commissioner making arrangements for the conduct of an election for those offices by the Australian Electoral Commission (AEC), as the Delegate was satisfied that an election for the abovenamed offices was required to be held under the rules of the organisation.
- [3] However, as a result of the delay in the conduct of most industrial elections by the Australian Electoral Commission (AEC), arising from the COVID-19 pandemic and associated restrictions, election E2020/45 was among the elections delayed. On 22 April 2021, the AEC confirmed that election E2020/45 has not yet been conducted.
- [4] The offices that were the subject of this decision **E2020/45** are the same as those listed in prescribed information lodged by the Association on 23 March 2021 in **E2021/55**.
- [5] On 27 April 2021 I issued a decision making arrangements for the conduct of the scheduled election in **E2021/55** by the AEC.<sup>1</sup>

[6] Clearly two elections are not required for the same offices. In order to prevent a duplication of elections, this amending decision is issued to advise that the election that would otherwise arise from the Delegate's decision dated 12 May 2020 in **E2020/45** is no longer required.
