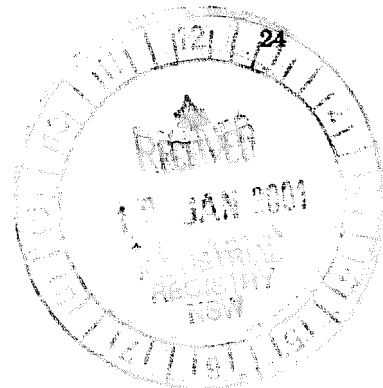

RE: Election of Office Holders for the Motor Traders' Association of New South Wales

I am writing to you to request that you arrange for the election of Office Holders for the Association. I supply the following information with regard to the election as required by Reg 61 of the Work Place Relations Act.

The term of office for a number of Office Holder positions will expire at the Associations AGM, which will be held in March 2001. These positions are Division Councillors, Division Alternate Councillors, Trustees and Executive Board members.

The Constitution sets out the election process for the positions as follows:

- Councillors and Alternate Councillors are elected from the members of each Division as set out by Rule 39.
- Trustees are elected from the members of the Association as set out by Rule 39.
- Executive Board members are elected from the Councillors elect as set out by Rule 40.

The number of Councillor and Alternate Councillor positions for each Division are set out in Rule 29(2) (recently amended) of the Constitution and vary in accordance with the number of members in each Division.



Although no date or time is set in the Associations Constitution and Rules for the commencement and close of a period for the receipt of nominations, MTA normally opens the electoral process in October of each year. This is done by including a nomination form for the positions of Councillors and Alternate Councillors and Trustees in the MTA Journal (see Rule 39(8) and 39(9)).
