# **DECISION**

Fair Work (Registered Organisations) Act 2009 s.189 – Arrangement for conduct of an election

Musicians' Union of Australia (E2012/395)

LINTON DUFFIN

MELBOURNE, 5 NOVEMBER 2012

Arrangement for conduct of election.

[1] On 25 October 2012 the Adelaide Branch of the Musicians' Union of Australia lodged with Fair Work Australia the prescribed information in relation to an election for the following offices:

Branch President	(1)
Branch Vice-Presidents	(2)
Branch Committee Members	(8)
Branch Trustees	(3)

- [2] On 26 October 2012, the Secretary of the Adelaide Branch lodged a request for an extension of time and for the General Manager to allow a later day than the prescribed day for lodgment of the prescribed information. Section 189 (2) of the *Fair Work (Registered Organisations) Act 2009* mandates that the prescribed information must be lodged before the prescribed day or such later day as the General Manager allows.
- [3] The prescribed day is established pursuant to Regulation 138(3) which provides that the prescribed days is to be 2 months before the first day when a person may, under the rules of the organization or branch, become a candidate in an election. The date on which the nominations are intended to open is 3 December 2012, which means that the prescribed information was lodged three weeks later than the prescribed day. In his letter, the Secretary submitted reasons for the delay in lodging the prescribed information.
- [4] Section 5(3) of the Fair Work (Registered Organisations) Act 2009 indicates that Parliament's intention when enacting this legislation was, amongst other things, establishing standards to:
  - (a) ensure that employer and employee organizations registered under this Act are representative of and accountable to their members, and are able to operate effectively; and
  - (b) encourage members to participate in the affairs of the organizations to which they belong; and...
  - (d) provide for the democratic functioning and control of organizations.

- [5] In this context, it must be recalled that elections are one of the key mechanisms for ensuring that organizations registered under the Act are representative and accountable to members. Accordingly, extensions of time should not be routinely sought. On the contrary, every effort must be made to lodge the prescribed information before the prescribed day.
- [6] After considering all the circumstances, I am satisfied that the Secretary of the Adelaide Branch is aware of the legislative requirements and the rules of the organization and will take steps to ensure compliance in the future. I allow a later day for lodgment of the prescribed information up to the date of actual lodgment, namely 25 October 2012, and grant the extension requested.
- [7] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the Fair Work (Registered Organisations) Act 2009, I am making arrangements for the conduct of the election by the Australian Electoral Commission.

# Lodgement of Statement and Notice of Prescribed Information for an Election

I write to request an extension of time to the attached lodgement of the Adelaide Branch of the Musicians' Union of Australia's Statement and Notice of Prescribed Information for an Election.

As a result of the declaration of the last election of the Committee of Management of the Adelaide Branch being delayed until February 2011, I was in the process of attempting to secure the unanimous consent of the Branch office holders to agree to shorten their elected terms of two years by two months so that elections could be completed by the end of 2012 and thus resynchronise our elections with the Rules of the organisation which indicate that elections should be held in even numbered years. Unfortunately, whilst endeavouring to receive written consents from the committee I now realise that the opportunity for holding the elections by the end of 2012 has expired. However, it is my intention that the calling of the election be initiated before the end of this year to assist in resynchronising the calling of elections with the rules of the organisation. Hence, I request that we be allowed to reduce "the day occurring 2 months before the first day when a person may, under the rules...become a candidate in an election." to 1 month for this election only.

# Elections - Musicians' Union of Australia, Adelaide Branch

I am writing to you in relation to the elections for offices in the Branch which must be conducted at the expiry of the current term of office.

The last election conducted for the Branch's offices was E2010/2669. The Delegate's decision in that matter was granted on 16 September 2010 and the result of the election was declared on 11 February 2011.

There are two issues which I must draw to your attention and about which I seek your comment.

## Election years

The first is that Rule 73C(a) of the rules of the organisation provides that elections for the offices other than Secretary are to be held every second year after 1982. Rule 73D provides that terms of office will be for the periods specified or until successors are elected. It may be thought desirable as well as reasonable therefore to ensure that elections are, as far as practicable, held at approximately the same time each election year so that the two-year terms will coincide with the even-numbered years specified in rule 73C(a).

However the current term technically commenced with the declaration by the Returning Officer in the early part of an odd-numbered year. I am conscious that, over time, a tension could arise between the desire to complete elections and thereby commence and end terms in the even-numbered years on the one hand, and the desire to observe the full period of office from declaration to declaration, where for any reason the conduct or completion of an election is delayed.

Presently, the nominal term for the offices elected in the last election will expire on 11 February 2013. If my interpretation of rule 73C(a) is correct, the Branch may wish to consider how it might most practicably bring its next election into alignment with the even-numbered year schedule contemplated by that rule.

This brings me to the second issue.

# Prescribed day

Sub-section 189(2) of the Fair Work (Registered Organisations) Act 2009 provides that "prescribed information must be lodged before the prescribed day or such later day as the General Manager allows." Regulation 138(3) says that the prescribed day is "the day occurring 2 months before the first day when a person may, under the rules...become a candidate in an election"

The first day a person can become a candidate is the opening day of nominations. The rules of the organisation do not identify a set date for the opening of nominations, merely that it shall be one month before the closing.

It is possible that the reference to 1 July 1982 in rule 73C(a) suggests that elections should commence on or soon after that date. Whatever date is arranged for the opening of nominations, the prescribed information must be lodged at least 2 months prior to the time when nominations will open. And in any case, it must be lodged before the nominal expiry of the term on 11 February 2013.

The details of the conduct of elections are the responsibility of the Australian Electoral Commission's Returning Officer, but if the Branch agrees that it would be desirable to complete the next scheduled election in the election year of 2012, lodgement of the prescribed information should occur sooner rather than later during the second half of 2012. A declaration of results by the Returning Officer, even in late 2012, would involve, in this case at least, a slight truncation of the actual two year term period for each current other office-holder on the Committee.
