Dear Mr Price,

I have forwarded your statement of Prescribed information to the FWA Delegate. She has noted that, strictly speaking, your term of office as Secretary is not due to expire until 4 years has elapsed, which will not be until early 2013. Thus, if an election for your position is held now, it means that your term of office will have been shortened by several months.

However she has also noted that the elections have got out of kilter with the two and four year cycles envisaged by the rules (73C) and that an election for all the Branch offices now in an even-numbered year would bring the elections back into harmony with each other and the rules.

Under the circumstances, she has asked me to request you to provide us with a signed letter that (1) confirms that you understand that this election will shorten your current term as Secretary and that you consent to your current term being shortened by an election at this time; and (2) confirms that the purpose for holding an election for the Branch Committee and Secretary positions at this time is to synchronise the elections for them all.

Dear Mr Price,

I refer to the statement dated today which you have forwarded to our office in relation to a Branch election.

In the statement you refer to "I confirm that the following information is being lodged under subsection 189(1) of the <u>RAO Schedule</u>". This reference is to repealed legislation. It means that from a strictly formal point of view, the statement is not compliant. The correct reference should be "I confirm that the following information is being lodged under subsection 189(1) of the Fair Work (Registered Organisations) Act 2009".

I will begin preparing documentation for a determination by the Delegate of Fair Work Australia. However, as I am required to officially forward a copy of the statement to the Australian Electoral Commission (notwithstanding that you have yourself done so), and because the Decision of the Delegate must be made upon and reflect lodgement under the correct legislative provision, I would ask you to send me a fresh amended signed statement that contains this correction.
