Arrangement for conduct of election.

[1] On 18 June 2012 the Sydney Branch of the Musicians' Union of Australia lodged with Fair Work Australia the prescribed information in relation to an election for the following offices:

Branch President	(1)
Branch Vice-Presidents	(2)
Branch Treasurer	(1)
Branch Committee Members	. (7)
Branch Trustees	(3)

- [2] On 20 June 2012, the Secretary of the Sydney Branch lodged a request for an extension of time and for the exercise of the General Manager's discretion to allow a later day for lodgment of the prescribed information.
- [3] On 27 June 2012, the Secretary lodged a further letter in respect of the request for an extension of time, in which he outlined in more detail the reasons for the delay in lodging the prescribed information.
- [4] The notification of an election was significantly overdue, the nominal 2 year term of office which commenced after the previous election having expired in April 2011. It appears that only one of the two-year term offices was filled at the previous election which resulted in co-management of the Branch by the Federal Office. It also appears that internal disputes and losses in membership have contributed to deficiencies in the Branch's ability to manage its own affairs. The Secretary has stated that during this period attention was not given to the requirements of the legislation and the rules of the organisation regarding the timing of elections.
- [6] I accept that the request for an extension of time has been made in good faith. After considering all the circumstances, I am satisfied that the current officeholders of the Sydney Branch are now aware of the requirements of the legislation and the rules of the organisation and will take steps to ensure compliance in the future. On that basis, I am prepared to exercise the discretion to allow a later day for lodgment of the prescribed information up to the date of actual lodgment, namely 18 June 2012, and grant the extension requested.

[7] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the Fair Work (Registered Organisations) Act 2009, I am making arrangements for the conduct of the election by the Australian Electoral Commission.

## Re: Sydney Branch elections - request for extension of time - s189(2) Fair Work (Registered Organisations) Act 2009

I refer to my previous two communications regarding the above subject and will now outline my reasons for respectfully requesting an exercise of the General Manager's discretion to allow a later day for lodgement be exercised and an appropriate extension of time for lodgement be granted.

In 2006 the Secretary and Committee of the Sydney Branch resigned and in a complicated process attempted to take the members of the branch into an amalgamation with another union using a NSW state registered body as a vehicle. These actions led to the Federal Executive of the Musicians' Union of Australia instructing the Federal Secretary to take over the affairs of the Sydney Branch. Lengthy proceedings in the NSW Industrial Court followed.

In late 2008 the Federal Secretary applied for an election and the results of this election were declared on 14 April 2009. Unfortunately only two nominations had been received so the Branch was left with just a Secretary and one Vice-President. The deficiency in office holders led to the affairs of the Sydney Branch being effectively co-managed by the Federal Office. In response to the minimal interest shown by members in nominating for office, efforts were made to identify members who might be convinced to participate in the running of the Branch.

Over this period of the attempted rebuilding of the Sydney Branch (which had also suffered a serious decline in membership due to the situation described above) we unfortunately did not turn our minds to the requirements of the Act and the rules of the Musicians' Union of Australia regarding the timing of elections. These requirements have been recently pointed out to us. Now that they have, we respectfully request the exercise of the General Manager's discretion to enable us to ensure that the membership of the Branch has the opportunity to participate in the democratic process of selecting officers to run the Branch.

Re: Elections - Musicians' Union of Australia, Sydney Branch

I refer to the Annual Return of Information lodged under section 233(1) of the *Fair Work (Registered Organisations) Act 2009* ('the Act') which was received by Fair Work Australia on 15 March 2012.

The Return lists, in accordance with regulation 147(e), the offices for which elections are due in 2012. These include all offices, with the exception of office of Secretary, in the Sydney Branch.

The last election conducted for the Branch was E2008/286, declared 14 April 2009. The expiry of term for the office of Secretary will occur in April 2013 and prescribed information will have to be lodged sufficiently in advance of the commencement of the election process to comply with section 189(2) of the Act. Section 189(2) provides that this must be lodged "before the prescribed day". Regulation 138(3) defines the prescribed day as "the day occurring 2 months before the first day when a person may, under the rules of the organization or branch, become a candidate in an election." That is, the prescribed information must be lodged 2 months prior to the opening date of nominations.

However, under the rules, elections for other offices must be held biennially. Therefore the term of office for other offices expired in April 2011. The election is therefore overdue by just over one year and prescribed information must be lodged for the other offices in order to give timely effect to the rules of the organization and comply with the statutory obligations.

I attach an extract from Regulation 138 which sets out the required information.
