Rules difficult to apply/interpret: Rules regarding Eligibility of persons nominating to be

Chapter Secretary are difficult to apply.

Rule 26 is silent on eligibility to hold office. The 'financiality' requirement as found in Rule 42 would require a person to be a financial member. However, there are rule references which infer a different

approach.

There is an expectation within Rule 5 (a) that there will be people who are eligible for membership by having been or becoming an elected officer, and not because

they are from within the industry.

Rules 27 and 28 appear to exempt the Chapter Secretary from the normal financiality provisions.

While none of the rules clearly state that a candidate for Chapter Secretary may come from outside the organisation, there are sufficient inferences that this could be the case. The RO therefore took a broader 'inclusive' interpretation of the rules to allow a person

to be a candidate.

The RO also sent nomination forms and Notice of election to all Chapter members. The rules are clear on who can be a nominator (Chapter Committee member only) but not on who can be a candidate for

Chapter Secretary.
