#### Reminder of actions required when persons elected to office

The Australian Electoral Commission has provided the Registered Organisations Commission (the ROC) a declaration of results for the election of stages 1, 2 and 3 uncontested offices for NSW, ACT, WA, TAS, VIC, QLD, National and SA Branches [E2017/29]. This letter is a reminder of certain obligations imposed on organisations and on persons elected to office.

#### A notice must be published on the organisation's website

The organisation or branch must publish on its website a notice that a copy of the report is available from the organisation, branch or the AEC on request. The notice must be kept on the website for a period of at least 3 months (see regulation 141 of the Fair Work (Registered Organisations) Regulations 2009).

#### Holders of office required to undertake approved training

Section 293K of the *Fair Work (Registered Organisations) Act 2009* (the RO Act) requires each officer with financial management duties to undertake approved training that covers those duties within 6 months after the person begins to hold office. Please ensure that relevant officers undertake approved training within the required timeframe. Please also ensure that all new holders of office are advised of their obligations to make disclosures regarding remuneration, non-cash benefits and material personal interests, the details of which are provided for in the RO Act.

#### Organisation must notify the Commission of changes

Also, section 233(2) of the RO Act requires that an organisation must notify the Commission within 35 days of any changes to the holders of office in the organisation. If there are no changes a notification is not required. **SA Chapter** : Ballot papers for the Stage 1 election *Management Committee* were re-issued to members due to an error made by the Returning Officer. The ballot period was extended and members were provided with an explantory note to explain the new voting arrangements.

# Other Matters

1) VIC Chapter: It is strongly recommended that the rules are varied to allow for a longer nomination period and ballot period. Australia Post delivery estimates 4 working days for post to be delivered to country locations within the same state and 6 working days for interstate postage. The rules do not allow for sufficient time for members to receive their materials, consider their materials, make a vote/nomination, and return to the AEC.

The rules should also allow for sufficient time for a recall election, should it be necessary. It may be necessary to open nominations prior to the first day of April for Stage 1 election.

2) TAS Chapter: The Returning Officer rejected two nominations for the office of Councillors for the Whole Chapter as the nominees already held the position of Councillor for the Northern and North Western region. The Returning Officer is of the view that the organisation's rules do not permit members to hold multiple Councillor positions at the same time. NECA should consider rules to resolve this issue in future election. The <u>AEC Model Rules</u> may be used as a guide, particularly paragraph 8 relating to multiple nominations, holding more than one office, nominations for more than one office, and election to an office while already holding another office.



Other irregularities identified, and action taken

During the conduct of the Stage 1 ballot for members of the Management Committee the Returning Officer was notified of an incorrect given name for a candidate on the ballot paper. This ballot was cancelled and a new ballot paper was distributed to the members of the Chapter, together with an explanatory note to explain to voters the new voting arrangements and the extended ballot period. This process achieved the requirements of the organisations rules.

# Other Matters

During the course of the ballot there was interest from candidates in distributing to voters, a profile or statement from each candidate.

It is recommended that this process be updated in the organisation's rules so that the process of candidate statements is managed by the Returning Officer. An example of a rule is:

"In elections to fill offices in accordance with these Rules, each candidate shall be entitled to, within five working days of the time fixed in accordance with these Rules for the close of nominations, submit to the Returning Officer a statement (together with a photograph of the candidate if desired) in support of the candidature. Such statement shall not exceed two hundred words. The Returning Officer shall reject any statement or photograph which does not comply with this Rule and may reject any statement or photograph the publication of which may be defamatory or in breach of the law. A candidate whose statement or photograph is rejected shall be given not more than ten days from the close of nominations to supply a replacement statement or photograph that complies with this Rule and remedies the defect. The Returning Officer shall arrange the printing of the statement and photograph in support of each candidate.

The Returning Officer shall include with the ballot paper delivered to each voter a copy of the statement and photograph printed in relation to each candidate. Where no statement or photograph has been submitted to the Returning Officer by a candidate the Returning Officer shall indicate this on a separate sheet which shall be delivered with each ballot paper."

#### Reminder of actions required when persons elected to office

The Australian Electoral Commission has provided the Registered Organisations Commission (the ROC) a declaration of results for the election of Stage 1 uncontested offices for Councillors of the Queensland Chapter Branch [E2017/29]. #### A notice must be published on the organisation's website
