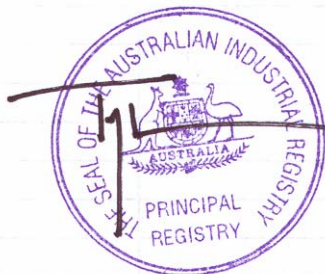
Arrangement for conduct of election.

**Section 189 (1) of RAO Schedule Workplace Relations Act (RAO Schedule) –
Request for Elections to be Conducted**

I, Lindsay Le compte, Chapter secretary (filling casual vacancy as per Rule 26 (c)) of the National Electrical Contractors Association, Australian Capital Territory Chapter, am authorised to sign this statement under the Rules of the organisation. I request that an election of Chapter secretary be conducted and the prescribed information in accordance with Regulation 138 of the RAO Schedule, s89 (1) is as follows:

- The name of office for which an election is required: Chapter Secretary.
- The reason for the election: Casual vacancy has occurred.
- Electorate: Members of ACT Chapter.
- The date and time of the beginning and end of nominations: Refer to Rule 26 (b), ie, Nominations close not less than 7 and not more than 28 days from the date of delivery or posting of nomination forms.
- The date on which the roll of voters is to be closed: Refer to Rule 26 (b), ie, The Chapter Returning Officer shall close the roll of voters for the election of the Chapter Secretary 10 working days prior to calling for such nominations.
- Kind of voting system: Direct voting system (elected from committee by members of the Chapter).
