Re NTEU Election Request for 2007 - dated 25 January 2007.

Further to the discussions between NTEU staff and you on 3 April, 2007, I now advise as follows regarding the NTEU 2007 supplementary election request;

- In respect of the positions of Division Assistant Secretary Academic Staff (ACT Division) and Division Assistant Secretary General Staff (WA Division), the persons declared elected were subsequently elected as the Presidents of their respective Divisions. These declarations have been submitted to you, as part of our initial request. As such, they are by virtue of the rules no longer the Division Assistant Secretary, and therefore a vacancy exists by reason of a vacated position;
- No request was made or intended in respect of the position of National Councillor for the Northern Territory.
- In respect of the Indigenous positions held by Maureen Ah Sam, a revised resignation is enclosed.
- In respect of the Indigenous Division Executive Member in Queensland, the reason for election should have been "vacated position".
- The request is withdrawn insofar as it deals with the following positions: Division Executive Member (Victoria); Ordinary Committee Member (Charles Darwin University Branch); Edith Cowan University Branch Vice-President (Academic Staff); Charles Sturt University Branch, Mitchell Sub Branch Ordinary Committee Member; Ordinary Committee Member (General Staff) and Branch Ordinary Committee Member in the University of South Australia Branch.
- In respect of the positions of Ordinary Committee Member (Academic Staff) in the Monash University Branch and Ordinary Committee member (General Staff) in the University of Queensland Branch, in each case only one position should have been requested;
- In respect of the position of Alternate National Councillor in the University of Western Australia Branch, one position remained unfilled after the election was concluded. The other position was filled by Gabe Gooding, who immediately became a University of Western Australia Branch National Councillor. This was because Tom Stewart

could not take up the position, as he held the position of National Executive member / at the time. As such, Gabe Gooding was no longer the Alternate National Councillor, and therefore a vacancy exists by reason of a vacated position.

I have attached a revised Table which is to be attached to our application in replacement of the one previously submitted. We seek leave to amend our application accordingly.



NATIONAL TERTIARY EDUCATION INDUSTRY UNION - REQUEST FOR ELECTIONS TO BE HELD.

- I, GRAHAME McCULLOCH, General Secretary of the National Tertiary Education Industry Union, hereby request, pursuant to Section 189 of Schedule 1 of the Act, that the Registrar arrange for the conduct of this organisation's supplementary elections and scheduled elections in 2007, and state as follows:
 - 1. Elections are required for those positions specified in the attached table, Attachment A.
 - 2. (a) The name of each office (138(1)(a)) is specified in the first and second columns of Attachment A
 - (b) The reason for the election (138(1)(b)) is as specified in the fifth column of Attachment A, according to the Key to Election Request which is at Attachment B.
 - (c) Where more than one of the offices in respect of which an election is required have the same name (138(1)(c)) the number of such offices is as specified in the third column of Attachment A, headed "No. Required".
 - (d) The electorate from which each office is to be elected (138(1)(d)) is as indicated in the fourth column of Attachment A, headed "Elected By", read in conjunction with Attachment B.
 - (e) The voting system to be employed (138(1)(g)) in the conduct of the election is as indicated in the sixth column of Attachment A read in conjunction with Attachment B.
 - (f) The period during which nominations may be called (138(1)(e)) for the scheduled election for the University of Western Australia and South West Institute of TAFE is between February 2007 and such date as would see the declaration of the poll prior to 1st October 2007; and for the supplementary election, it is not prescribed by the rules.
 - 3. The terms of office for each position in the attached table is two years, from 1 October 2006, or as otherwise provided in the rules, except that the positions of Branch Officers and Branch Committee in each of the South-West Institute of TAFE Branch and the University of Western Australia Branch, each of which has a one year term from 1 October 2007.
