

NATIONAL TERTIARY EDUCATION INDUSTRY UNION - REQUEST FOR ELECTIONS TO BE HELD.

I, **GRAHAME McCULLOCH**, General Secretary of the National Tertiary Education Industry Union, hereby request, pursuant to Section 189 of the Fair Work (Registered Organisations) Act 2009, that the General Manager arrange for the conduct of this organisation's elections in 2012, and state as follows:

1. Elections are required for those offices specified in the attached table, Attachment B.
2.
 - (a) **The name of each office** (Regulation 138(1)(a)) is specified in the first and second columns of Attachment B.
 - (b) **The reason for the election** (138(1)(b)) is as specified in the fifth column of Attachment B, according to the Key to Election Request which is at the Annexure to Attachment B.
 - (c) **Where more than one of the offices in respect of which an election is required have the same name** (138(1)(c)) the number of such offices is as specified in the third column of Attachment B, headed "No. Required".
 - (d) **The electorate from which each office is to be elected** (138(1)(d)) is as indicated in the fourth column of Attachment B, headed "Elected By", read in conjunction with the Annexure to Attachment B.
 - (e) **The voting system to be employed** (138(1)(g)) in the conduct of the election is as indicated in the sixth column of Attachment B read in conjunction with the Annexure to Attachment B.
 - (f) **The period during which nominations may be called** (138(1)(e)) is 1 February 2012, to such date as would see the elections declared before the terms of office commence, except that no time is prescribed by the rules in relation to new positions.
3. The terms of office for each office in the attached table is two years, except for the positions of Division Secretary in the New South Wales, Australian Capital Territory, Western Australian, and South Australian Divisions, which are now designated as full-time offices (Rule 69.8). No election is required for Division Secretary in the Victorian and Queensland Divisions, or for National President, General Secretary or National Assistant Secretary, which have four year terms from 2010.
4. I have included in Attachment B in the left hand column in respect of each Branch where it is relevant in determining the number of National Councillors a Branch is to elect, the number of members of the Branch (Rule 18.1). This number is in brackets – e.g. ("897"). The listed number is based, as required by the rules on the membership

numbers according to the best records held by the General Secretary as at 31 March 2012 (Rule 18.1).

5. Specifically, you will note that the Victorian TAFE Branch has 4 National Councillors to be elected and the ACE and Companies Branch has one National Councillor to be elected, pursuant to the terms of Sub-Rule 18.3.
6. **The date provided for in the rules as the day on which the roll of voters is to be closed** (138(1)(f)) is the seventh day before the date determined for the opening of nominations (72.1).
7. In accordance with the rule change submitted to Fair Work Australia in matter R2011/221, and specifically the Rule 18.3 I, an election is only requested for the position of Indigenous Branch Committee Member at those Branches where, according to the Union's records today, and the Union has Indigenous members. I have caused the records of the Union to be checked in respect of each Branch and the requests corresponds to the result of that check.
8. This request is incomplete in one respect. The Western Australian Division Council has not yet made a determination under Sub-rule 31.3 as to the number of Ordinary Members of the Division Executive it is to have, and that Division Council does not meet for some weeks. It is submitted that the election for these collegiate positions (which will in the usual course of events not occur before September 2012) will be the subject of a further request, subject to approval by Fair Work Australia of this course of action.
9. I can confirm that each of the entities, other than the ANU Branch, entitled to elect an Additional Divisional Councillor in the ACT Division has less than 400 members.
10. I can confirm that the University of Tasmania Branch continues to be the only Branch in Tasmania.
11. Subject to the qualification set out in 8 above, this request reflects the rule changes approved by Fair Work Australia in matter R2011/221. In addition to that, there are changes effected by Branches pursuant to the Rules as follows:
 - (a) The University of Technology Sydney Branch has abolished the Gore Hill Sub-Branch.
 - (b) The University of Western Sydney Branch has resolved to abolish all of its Sub-Branches
 - (c) The University of Melbourne Branch has resolved to abolish the Victorian College of Agriculture and Horticulture Sub-branch of the Branch.
 - (d) The University of Notre Dame Branch has resolved to alter the number of Ordinary Committee Members to six, and pursuant to the rules now has a sufficient number of both academic and general staff members to require the

election of both a Vice President (Academic) and Vice President (General Staff).

I certify that to the best of my knowledge and belief, and based upon advice given by the relevant Branches these changes have been made in accordance with the Rules.

12. In addition to these changes, I am advised that an election was required under the rules for the position of Treasurer in the Charles Sturt University Branch of the Union in 2010 (as it was in 2008) but was omitted in error. This request therefore includes that position.

13. NTEU's National Executive in April 2012 has passed two resolutions as follows:

National Executive resolves to establish a NAVITAS Branch of the Union to consist of members employed by or in connection with NAVITAS (meaning any member of the NAVITAS group of corporations), but not including any person primarily employed by an institution in connection with a Branch is established. Until a determination is made by the Branch itself, in addition to the Officer and Indigenous positions mandated by the Rules, the Branch Committee shall include four Ordinary Committee Members.

A. *National Executive resolves to establish a Research Institutes Branch to consist of members employed;*

1. *By or in connection with any of the following:*

- *Howard Florey Institute*
- *Ludwig Institute*

2. *By or in connection with any other research institute (not being a University) in the State of Victoria;*

- *which is established for a charitable, educational or other public purpose, and*
- *which is either affiliated with a university or where employees hold academic titles associated with higher education, and*
- *where the supervision of postgraduate students occurs;*

other than any member who is employed in or in connection with any institution in respect of which another Branch is established.

- B. Until a determination is made by the Branch itself, in addition to the officer and Indigenous positions mandated by the rules, the Branch Committee shall include four Ordinary Committee Members.*
