**Reminder of actions required when persons elected to office**

The Australian Electoral Commission has provided the Commission a declaration of results for the election [E2015/148]. This letter is a reminder of certain obligations imposed on organisations and persons elected to office.

Section 154D(1) of the *Fair Work (Registered Organisations) Act 2009* (the RO Act) requires the rules of organisations (and branches of organisations) to require each officer with financial management duties to undertake approved training that covers those duties within 6 months after the person begins to hold office. Please ensure that relevant officers undertake approved training within the required timeframe.

Please also ensure that all new holders of office are advised of their obligations to make disclosures regarding remuneration, non-cash benefits and material personal interests, the details of which should be provided for in your organisation's rules.

Also, section 233(2) of the RO Act requires that an organisation must notify the Fair Work Commission (the Commission) within 35 days of any changes to the holders of office in the organisation. If the election has resulted in any changes to the holders of office, the National Tertiary Education Industry Union must notify the Commission of these changes. In particular, please advise:

1. Person(s) who have ceased to hold office:
  - the name of the office vacated;
  - the date of the change of office holder; and
  - the name of the person vacating the office.
2. Person(s) who have commenced to hold office:
  - the name of the office now held;
  - the date of the change of office holder;
  - the name of the person now holding the office;
  - the postal address of the person (generally the postal address of the organisation); and
  - the occupation of the person now holding the office.

The notification must include a declaration by the Secretary (or other prescribed officer) that the information is a correct statement of the changes made. I have attached a template notification of changes which may assist you. If any change does not apply until a specific date, you don't need to notify until then (e.g. AGM, 1 January, 2nd Monday in March). If you have already lodged this information, please disregard this reminder.

**Organisation to respond to post-election report regarding rules difficult to apply/interpret: E2015/148**

The Australian Electoral Commission has provided the Fair Work Commission with a copy of the post election report (PER) for the National Tertiary Education Industry Union (NTEU) election E2015/148 dated 30 November 2015. The PER identifies rules that were difficult to interpret or apply, in particular rule 72.15. This letter serves as a reminder of the obligations imposed on the NTEU as a consequence of the AEC's report. Please ignore this letter if the below-listed actions have been undertaken already.

Section 198 of the *Fair Work (Registered Organisations) Act 2009* (the RO Act) requires the National Tertiary Education Industry Union to provide a written response to the AEC within 30 days of receipt of the report (s198). The response must specify whether and what action the organisation intends to take (s198(2)).

Also the NTEU must make available to its members the relevant extract of the AEC report and a copy of the *response* (s198(3)). The relevant extract is the part of the post-election report which identifies rules that were difficult to interpret or apply.

The copy of the response must be made available to members either:

- within 30 days after the response is given to the AEC, or
- published in the next edition of the organisation or branch journal (s198(5))

The relevant extract must be made available to members no later than the day on which the response is made available to members.

Subsection 198(6) and regulation 142 prescribe ways in which the relevant extract and the response are to be made available to members. These do not limit the ways in which they can be made available to members. The NTEU will comply if it does all of the following:-

- publish the relevant extract and response in the next edition of the NTEU journal that it is reasonably practicable to do so; and
- within 30 days of giving the response to the AEC:
  - lodge with The Fair Work Commission a copy of the relevant extract and response, together with a declaration that the NTEU will provide a copy to any member who so requests; and
  - give notice in the next edition of the NTEU journal, or an appropriate newspaper that covers the relevant geographic area, that a copy of the relevant extract and response are available on request to each member free of charge; and
- if the NTEU has a web site, publish the relevant extract on the website within 14 days after receiving the post-election report, and publish the response on the website within 14 days of giving the response to the AEC (reg 142(2)).

As noted above, if the NTEU has undertaken these actions already, please disregard this letter.

Election Decision No: E2015/148

**RULES**

Rules used for the election: 283V: Incorporates alterations of 19 June 2015 (R2015/119)

Rules difficult to apply/interpret: 72.15

- the poor drafting practice in having two paragraphs numbered (a) and (b);
- inappropriate placement of the proviso (it should not appear at the foot of subrule 72.15 but should appear at the end of what becomes paragraph 72.15(c);
- inappropriate grammar (namely using 'shall' as both a mandatory requirement and a conditional requirement where the word 'must' is the more precise expression for the mandatory requirement).
- inappropriate punctuation (using a semi colon where a colon is required); and
- the omission to put in appropriate line breaks so that the reader may easily comprehend the effect of subrule 72.15.

The AEC suggests that the NTEIU address these problems by substituting the following as subrule 72.15 of the NTEU.

72.15 If, at the close of nominations:

(a) in respect of an election for one position, no nomination has been received, or

(b) in respect of an election where more than one position is to be elected, no or insufficient nominations have been received,

then the Returning Officer **must** declare any nominee properly nominated elected, but shall then as soon as reasonably practicable:

(c) advise the General Secretary of those positions for which no or insufficient nominations have been received,

(d) extend the closing date for nominations until noon on the seventeenth day after the date the General Secretary is notified under paragraph (c), (or the next day which is a working day in every State and Territory), **provided that the extension of nominations under this Sub-Rule may only happen on one occasion in respect of any election.**

As soon as practicable after receiving the advice referred to in (c) above, the General Secretary **must**



place prominently on the Unions Website, and **must** transmit to each Branch and Division Secretary, a notice, approved by the Returning Officer **that** sets out the positions which remain vacant, and the extended time and date for the close of nominations, the names and address(es) to which nominations should be directed, and the places from which nomination forms may be obtained.

The action taken to remedy this was to inform the nominees for the QUT that there was no position available and the nomination period for the QSU position was extended under the provision of rule 67.4 to activate 72.15 for this position.






