Reminder of actions required when persons elected to office

The Australian Electoral Commission has provided the Registered Organisations Commission (the ROC) a declaration of results for the election of uncontested and contested offices for National, ACT, NT, NSW, QLD, SA, VIC, TAS and WA Branches [E2017/229]. This letter is a reminder of certain obligations imposed on organisations and on persons elected to office.

A notice must be published on the organisation's website

The organisation or branch must, as soon as practicable after receiving the post-election report, publish on its website a notice that a copy of the report is available from the organisation, branch or the AEC on request. The notice must be kept on the website for a period of at least 3 months (see regulation 141 of the Fair Work (Registered Organisations) Regulations 2009).

Holders of office required to undertake approved training

Section 293K of the *Fair Work (Registered Organisations) Act 2009* (the RO Act) requires each officer with financial management duties to undertake approved training that covers those duties within 6 months after the person begins to hold office. Please ensure that relevant officers undertake approved training within the required timeframe. Please also ensure that all new holders of office are advised of their obligations to make disclosures regarding remuneration, non-cash benefits and material personal interests, the details of which are provided for in the RO Act.

Organisation must notify the Commission of changes

Also, section 233(2) of the RO Act requires that an organisation must notify the Commission **within 35 days of any changes** to the holders of office in the organisation. **If there are no changes a notification is not required.** If the election has resulted in **any changes** to the holders of office, the National Tertiary Education Industry Union must notify the Commission of these changes. In particular, please advise:

1. Person(s) who have ceased to hold office:
 - the name of the office vacated;
 - the date of the change of office holder; and
 - the name of the person vacating the office.

2. Person(s) who have commenced to hold office:
- the name of the office now held;
 - the date of the change of office holder;
 - the name of the person now holding the office;
 - the postal address of the person (generally the postal address of the organisation); and
 - the occupation of the person now holding the office.

The notification must include a declaration by the Secretary (or other prescribed officer) that the information is a correct statement of the changes made. A template notification of changes, which may assist you, is attached. If any change does not apply until a date in the future, you do not need to notify until then (e.g. AGM, 1 January, 2nd Monday in March). If you have already lodged this information, please disregard this reminder.

Returning Officer actions required (Section 193):

Details:

Rule 69.13 states that:

The Returning Officer shall, one week before the date of opening of nominations cause to be published in a newspaper or newspapers and in the Newsletter or another official publication of the Union, Division or Branch as the case may be a notice setting out:

(b) the title of the office or offices to be filled, and the number of positions vacant for each position;

Currently the AEC do not advertise the title of each office in the newspaper but rather the use a 'pointer' notice to redirect potential candidates to the NTEU website.

Rule 72.15 states that:

If, at the close of nominations ...no or insufficient nominations have been received, then the Returning Officer shall declare any nominee properly nominated elected, but shall then as soon as reasonably practicable:

- (a) *advise the General Secretary of those positions for which no or insufficient nominations have been received,*
- (b) *extend the closing date for nominations until noon on the nineteenth day after the date initially fixed as the date for the close of nominations*

It is very difficult for a Returning Officer to declare the uncontested offices and then re advertise the vacancies in the space of just nineteen days from the nomination close.

Either this period should be extended significantly or the extension be removed and the length of the nomination period extended.

Please see the attached table A that provides an a list of the nineteen days from the nomination close and the types of tasks that need to be completed to complete this in such a tight timeframe.

Rule 69.2 states that:

Every nomination shall be in writing, be in the appropriate one of the forms prescribed in Schedule B of these Rules, be signed by two financial members of the Union and, *in the case of a Branch or Division election, of the relevant Branch or Division* as nominators, and bear the written consent of the nominee.

The rules indicate that who can be a nominator for Branch and Division elections but are less clear for nominators at National Council or the TAFE Branch Committee elections.

Rule 70.5 states that:

The Returning Officer shall advise all voters of the closing date and hour for the receipt of returned ballot papers ***which shall be three weeks after the closure of nominations.***

The Returning officer cannot complete the declarations for uncontested offices, conduct ballot draws, prepare multiple candidate statement booklets and ballot papers, update the roll of voters and send out the ballot kits so that they return in three weeks from the close of nominations.

Rule 70.11 states that:

The result of the ballot shall be declared by the Returning Officer by *no later than 8.00 p.m. on the day no later than four weeks from the closure of nominations.*

Considering that there is one week withdrawal period after the nomination close date and the time it takes to prepare for the ballot to be sent out and returned by Australia post this is not enough time. If the

Returning Officer was to comply with this rule it would mean that the actual ballot open and close dates would only be approximately one week or less.

Rule 36.2 state that:

No person shall at the same time hold more than one of the following offices:

- (a) Branch President;
- (b) Branch Vice President;
- (c) Branch Secretary;
- (d) Branch Treasurer;
- (e) Ordinary Committee Member;
- (f) Aboriginal and Torres Strait Islander Branch Committee Member.

This rule could be expanded to include all incompatible offices (example - whether someone can hold a Branch Committee Member (Casual Employees) as well as Branch Committee member).

Rule 69.18 (elections of the Victorian TAFE Branch collegiate offices).

...where a Branch Committee is constituted on the basis that its membership *consists predominantly of Sub-Branch Presidents*..... the National Councillors from such a Branch shall be elected by and from the members of the Branch Committee.

This rule does not provide information regarding those eligible to be on the Branch Committee. There is also no information about who can nominate these candidates.



Arrangement for conduct of election.

[1] On 22 March and 26 April 2018 the National Tertiary Education Industry Union (the organisation) lodged with the Registered Organisations Commission (the ROC) prescribed information for an election to fill the following offices:

National, Divisional and Branch Offices as set out in Attachment A

[2] On the same dates, the organisation lodged with the ROC prescribed information under subsection 187(3) of the *Fair Work (Registered Organisations) Act 2009* (the RO Act) in relation to an election for the following positions:

Sub-Branch positions as set out in Attachment B

[3] On 1 May 2018, the organisation lodged submissions regarding the office of Secretary for each of the South Australia, New South Wales, Australian Capital Territory and Western Australia divisions. The election of these offices presents as appearing to be out of synchronisation with Rule 68A.1(c) of the relevant rules which sets out the expiration dates of offices. Staff of the ROC engaged with and received submissions from the organisation about that issue which included an acknowledgment that there ‘*is clearly a tension within the rules between the provisions of Sub-rule 68A.1 and the other rules...*’. The organisation indicated a preparedness to clarify the relevant tension by placing recommended rule amendments before the October 2018 meeting of its National Council.

[4] Having carefully considered the relevant rules, the prescribed information and further submissions lodged by the organisation, I am satisfied that an election for the abovenamed offices and positions is required to be held under the rules of the organisation. In accordance with subsection 189(3) of the RO Act, I am making arrangements for the conduct of the election by the Australian Electoral Commission.

NATIONAL TERTIARY EDUCATION INDUSTRY UNION - REQUEST FOR ELECTIONS TO BE HELD.

I, **GRAHAME McCULLOCH**, General Secretary of the National Tertiary Education Industry Union, hereby request, pursuant to Section 189 of the Fair Work (Registered Organisations) Act 2009, that the General Manager arrange for the conduct of this organisation's elections in 2016. Please note that this is an amendment to our previous request for elections dated 22 March 2018 and this is marked as number 14 below:

1. Elections are required for those offices specified in the attached table, Attachment B.
2.
 - (a) **The name of each office** (Regulation 138(1)(a)) is specified in the first and second columns of Attachment B.
 - (b) **The reason for the election** (138(1)(b)) is as specified in the fifth column of Attachment B, according to the Key to Election Request which is at the Annexure to Attachment B.
 - (c) **Where more than one of the offices in respect of which an election is required have the same name** (138(1)(c)) the number of such offices is as specified in the third column of Attachment B, headed "No. Required".
 - (d) **The electorate from which each office is to be elected** (138(1)(d)) is as indicated in the fourth column of Attachment B, headed "Elected By", read in conjunction with the Annexure to Attachment B.
 - (e) **The voting system to be employed** (138(1)(g)) in the conduct of the election is as indicated in the sixth column of Attachment B read in conjunction with the Annexure to Attachment B.
 - (f) **The period during which nominations may be called** (138(1)(e)) is 1 February 2018, to such date as would see the elections declared before the terms of office commence, except that no time is prescribed by the rules in relation to new positions. To be determined by the returning officer.
3. The terms of office for each office in the attached table is two years, except that it is four years for the positions of National President, General Secretary and National Assistant Secretary as well as the positions of Division Secretary in Victoria and Queensland, which are designated as full-time offices (Rule 69.8). No election is required for Division Secretary in the Australian Capital Territory, New South Wales, South Australian and Western Australian Divisions, which have four year terms from 2016.

4. I have included in Attachment B in the left hand column in respect of each Branch where it is relevant in determining the number of National Councillors a Branch is to elect, the number of members of the Branch (Rule 18.1). This number is in brackets – e.g. (“897”). The listed number is based, as required by the rules, on the membership numbers according to the best records held by the General Secretary as at 28 February 2018 (Rule 18.1).
5. Specifically, you will note that the Victorian TAFE Branch has a National Councillor to be elected and the ACE and Companies Branch has a National Councillor to be elected, pursuant to the terms of Sub-Rule 18.3. In both cases, these are Branches established in respect of a sector.
6. **The date provided for in the rules as the day on which the roll of voters is to be closed** (138(1)(f)) is the seventh day before the date determined for the opening of nominations (72.1).
7. In accordance with Rule 18.3 I, an election is only requested for the position of Aboriginal & Torres Strait Islander Branch Committee Member at those Branches where, according to the Union’s records today, the Union has Indigenous members. I have caused the records of the Union to be checked in respect of each Branch and the requests corresponds to the result of that check.
8. Other than the ANU Branch, I can confirm that each of the entities entitled to elect an Additional Divisional Councillor in the ACT Division each has less than 400 members.
9. I can confirm that the University of Tasmania Branch continues to be the only Branch in Tasmania.
10. As per rule 27.14 there are no Branches of the Union established in the Northern Territory and the Division Officers and Division Council in the Northern Territory Division shall be as set out in this sub-rule
11. The Central Queensland University Branch at a Branch Committee meeting abolished its Sub-Branch which was formerly Australian International Campus Sub-Branch
12. The University of Technology, Sydney Branch at a Branch Committee meeting abolished its Sub-Branch which was formerly Kuringai Sub-Branch
13. Attachment C to this statement sets out those positions which are required to be elected under the Rules of the NTEU but which are not considered to be offices as defined in Section 9 of the Fair Work (RO) Act 2009. NTEU requests that the elections for these positions be conducted by the AEC in accordance with s.187 of the Fair Work (RO) Act 2009.

14. An amendment to the NTEU Rules as been accepted by the Registered Organisations Commission under Rule 72. The rule change states that any Branch that has 20 or more Casual members will increase its committee by 1 to include a position (Branch Committee Member (Casual Employee)). The Branches that this rule change will effect are:

I, **GRAHAME McCULLOCH**, General Secretary of the National Tertiary Education Industry Union, hereby request, pursuant to Section 189 of the Fair Work (Registered Organisations) Act 2009, that the General Manager arrange for the conduct of this organisation's elections in 2016. Please note that this is an amendment to our previous request for elections dated 22 March 2018 and this is marked as number 14 below:

1. Elections are required for those offices specified in the attached table, Attachment B.
2.
 - (a) **The name of each office** (Regulation 138(1)(a)) is specified in the first and second columns of Attachment B.
 - (b) **The reason for the election** (138(1)(b)) is as specified in the fifth column of Attachment B, according to the Key to Election Request which is at the Annexure to Attachment B.
 - (c) **Where more than one of the offices in respect of which an election is required have the same name** (138(1)(c)) the number of such offices is as specified in the third column of Attachment B, headed "No. Required".
 - (d) **The electorate from which each office is to be elected** (138(1)(d)) is as indicated in the fourth column of Attachment B, headed "Elected By", read in conjunction with the Annexure to Attachment B.
 - (e) **The voting system to be employed** (138(1)(g)) in the conduct of the election is as indicated in the sixth column of Attachment B read in conjunction with the Annexure to Attachment B.
 - (f) **The period during which nominations may be called** (138(1)(e)) is 1 February 2018, to such date as would see the elections declared before the terms of office commence, except that no time is prescribed by the rules in relation to new positions. To be determined by the returning officer.
3. The terms of office for each office in the attached table is two years, except that it is four years for the positions of National President, General Secretary and National Assistant Secretary as well as the positions of Division Secretary in Victoria and Queensland, which are designated as full-time offices (Rule 69.8). No election is required for Division Secretary in the Australian Capital Territory, New South Wales, South Australian and Western Australian Divisions, which have four year terms from 2016.

4. I have included in Attachment B in the left hand column in respect of each Branch where it is relevant in determining the number of National Councillors a Branch is to elect, the number of members of the Branch (Rule 18.1). This number is in brackets – e.g. (“897”). The listed number is based, as required by the rules, on the membership numbers according to the best records held by the General Secretary as at 28 February 2018 (Rule 18.1).
5. Specifically, you will note that the Victorian TAFE Branch has a National Councillor to be elected and the ACE and Companies Branch has a National Councillor to be elected, pursuant to the terms of Sub-Rule 18.3. In both cases, these are Branches established in respect of a sector.
6. **The date provided for in the rules as the day on which the roll of voters is to be closed** (138(1)(f)) is the seventh day before the date determined for the opening of nominations (72.1).
7. In accordance with Rule 18.3 I, an election is only requested for the position of Aboriginal & Torres Strait Islander Branch Committee Member at those Branches where, according to the Union’s records today, the Union has Indigenous members. I have caused the records of the Union to be checked in respect of each Branch and the requests corresponds to the result of that check.
8. Other than the ANU Branch, I can confirm that each of the entities entitled to elect an Additional Divisional Councillor in the ACT Division each has less than 400 members.
9. I can confirm that the University of Tasmania Branch continues to be the only Branch in Tasmania.
10. As per rule 27.14 there are no Branches of the Union established in the Northern Territory and the Division Officers and Division Council in the Northern Territory Division shall be as set out in this sub-rule
11. The Central Queensland University Branch at a Branch Committee meeting abolished its Sub-Branch which was formerly Australian International Campus Sub-Branch
12. The University of Technology, Sydney Branch at a Branch Committee meeting abolished its Sub-Branch which was formerly Kuringai Sub-Branch
13. Attachment C to this statement sets out those positions which are required to be elected under the Rules of the NTEU but which are not considered to be offices as defined in Section 9 of the Fair Work (RO) Act 2009. NTEU requests that the elections for these positions be conducted by the AEC in accordance with s.187 of the Fair Work (RO) Act 2009.

14. An amendment to the NTEU Rules as been accepted by the Registered Organisations Commission under Rule 72. The rule change states that any Branch that has 20 or more Casual members will increase its committee by 1 to include a position (Branch Committee Member (Casual Employee)). The Branches that this rule change will effect are:
