Insufficient Nil Statements



Your ORP statement did not contain NIL statements in relation to the top 5 officers' relevant remuneration and non-cash benefits and this made it unclear whether you had fully completed the statement.

It is the view of the ROC that NIL statements provide greater clarity and transparency for members. Such statements reassure the organisation's members and the ROC that the organisation or branch has turned its attention to officers' relevant remuneration, their non-cash benefits and payments to related parties.

Please ensure that next year's ORP statement contains NIL statements instead of blanks or deleted rows.
