Re: s271 Exemption Certificate various for 30 June 2009

I refer to your letter of 14 October 2009 addressed to "The Registrar" Fair Work Australia. The letter was received at Fair Work Australia (FWA) on 20 October 2009. I also refer to a further letter of 16 November 2009, which was received at FWA on 18 November 2009.

In the original correspondence you make application "at the request and on behalf of each of the reporting units of the National Tertiary Education Industry Union (NTEU) set out in "a list attached to the application". The second piece of correspondence seeks to add two additional reporting units to the list of reporting units to be covered by the application.

I note that in support of the application you refer to the "force of Schedule G Section 3(a) of the NTEU rules" and secondly a statement that as a matter ".... of fact from 30 June 2008 the assets and liabilities of each of the Branches and Divisions have transferred to the custody and control of the "NTEU Fund".

I further note that apart from the Film and Television Branch and the Victorian Division, FWA has received audited financial reports from each of the relevant reporting units which verify as fact that relevant assets and liabilities have indeed been transferred in accordance with the rules. I expect that the remaining reports will be lodged shortly. I understand from your correspondence the appropriate financial reports for the organisation have not yet been completed, but that you expect that will occur by March 2010. I take this opportunity to remind you of the import of reporting units strictly complying with each aspect of the legislative reporting requirements under the Fair Work (Registered Organisations) Act 2009, the Fair Work (Registered Organisations) Regulations and the Reporting Guidelines.

I am satisfied that each of the Divisions/Branches nominated in your application is a reporting unit and that they did not have any financial affairs in the year ended 30 June 2009. The attached certificate reflects this decision. As a matter of convenience I have chosen to deal with each reporting unit under the one certificate.

I grant an extension of time for the making of the application(s). I do so on the basis of the particular circumstances of this application(s).

I advise the organisation that while I have determined to issue a certificate in relation to each of the nominated reporting units I will require further applications be made consistent with the provisions of section 271.




