Dear Mr McCulloch,

Re: Section 271 application for exemption from the financial reporting obligations of Part 3 of Chapter 8 of the Fair Work (Registered Organisations) Act 2009

I refer to your letter of 20 April 2011 addressed to 'The General Manager' Fair Work Australia. The letter was received at Fair Work Australia (FWA) on 21 April 2011. In this correspondence you make application 'at the request and on behalf of each of the reporting units of the National Tertiary Education Industry Union (NTEU) set out in' a list attached to the application.

I note that in support of the application you refer to the 'force of Schedule G Section 3(a) of the NTEU rules' and secondly a statement that as a matter '... of fact, from 30 June 2008 the assets and liabilities of each of the Branches and Divisions have transferred to the custody and control of the 'NTEU Fund".

I further note that FWA has received audited financial reports from each of the relevant reporting units which verify as fact that relevant assets and liabilities have indeed been transferred in accordance with the rules.

I am satisfied that each of the Divisions/Branches nominated in your application is a reporting unit and that they did not have any financial affairs in the year ended 30 June 2010. The attached certificate reflects this decision. As a matter of convenience I have chosen to deal with each reporting unit under the one certificate.

I grant an extension of time for the making of the application(s). I do so, on the basis of the particular circumstances of this application(s). I advise the organisation that while I have determined to issue a certificate in relation to each of the nominated reporting units I will require further applications to be made within 90 days after the end of the financial year. I take this opportunity to remind you of the import of reporting units strictly complying with each aspect of the legislative reporting requirements under the *Fair Work (Registered Organisations) Act 2009*, the *Fair Work (Registered Organisations) Regulations 2009* and the Reporting Guidelines.



RE: Application for exemption certificate - Financial Reporting Obligations under Fair Work (Registered Organizations) Act 2009 - (Section 271)

I Grahame McCulloch, being the General Secretary of the National Tertiary Education Industry Union, make this application at the request of and on behalf of the following reporting units of the National Tertiary Education Industry Union (NTEU) set out in the attached list.

In consideration of Section 271 of the Act I apply for a certificate to exempt the Branches and Divisions of the NTEU from the requirements relating to financial matters occurring in the year ending 30th June 2010.

In support of the application I state:

- 1. On and from 30th June 2008, by force of Schedule G Section 3(a) of the NTEU rules it is not possible for any Branch/Division/NTEU to have any financial affairs.
- 2. As a question of fact, from 30th June 2008, the assets and liabilities of each of the Branches and Divisions have transferred to the custody and control of the "NTEU Fund", and income and expenditure are respectively received into and disbursed from that fund.

It is anticipated that lodgement will take place in early May 2011.
