Re: Section 271 application for exemption from the financial reporting obligations of Part 3 of Chapter 8 of the *Fair Work (Registered Organisations) Act 2009*

I refer to your letter of 30 August 2011 addressed to 'The General Manager' Fair Work Australia. The letter was received at Fair Work Australia (FWA) on 30 August 2011.

In the correspondence you make application 'at the request and on behalf of each of the reporting units of the National Tertiary Education Industry Union (NTEU) set out in' a list attached to the application.

I note that in support of the application you refer to the 'force of Schedule G Section 3(a) of the NTEU rules' and secondly a statement that as a matter '... of fact, from 30 June 2008 the assets and liabilities of each of the Branches and Divisions have transferred to the custody and control of the 'NTEU Fund'.

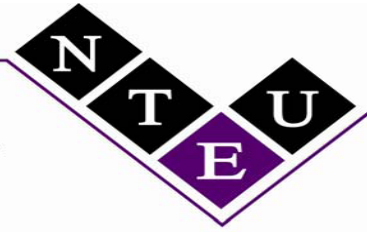
