

As the Division Secretary of the National Tertiary Education Union – Queensland Division I am authorised to write this letter. I am making this application at the request of and on behalf of the Bond University Branch, which is small and without office bearers.

In consideration of Section S271 of the Act, I apply for a certificate to exempt the Branch from the requirements of the Act relating to financial matters for the years ending 30 June 2007 and June 2008.

In support of the application I state:

- 1 The Branch does not hold an interest in any real or personal property.
- 2 The Branch does not act as a trustee in any form.
- The Branch does not have any funds prescribed under subrule 51,4 of the NTEU rules (as that rule was in force until December 2007) or under Schedule G, Sectoria (b).
- 4 The Branch's structure is not mirrored in the form of another organisation
- 5 Members pay their dues directly to the National office by direct debit, credit card or invoice. No dues are paid through the Branch.
- 6 A small amount per member is remitted back to the Division Office to be used if required for any activities on behalf of the members.
- 7 The Branch does not have any obligations which require it to hold its own funds.



S271A – Application for Certificate for years 2007 and 2008

As the Division Secretary of the National Tertiary Education Union – Queensland Division I am authorised to write this letter. In 2004 the annual elections of the union was held and there were two Branch Officers elected at Bond University. However, since that time both elected officials have resigned and the positions remain vacant despite elections in 2006 and again recently in 2008. Nothing has changed regarding financial matters at the Branch Level and we consequently will not be lodging financial statements for the years 2007 and 2008. In accordance with S271A of the Act, I apply for a certificate to exempt the Branch from the requirements of the Act relating to financial matters for the years ending 30 June 2007 and June 2008.

In support of the application I say:

- 1 The Branch does not hold an interest in any real or personal property
- 2 The Branch does not act as a trustee in any form
- 3 The Branch does not have any funds prescribed under subrule 51.4
- 4 The Branches's structure is not mirrored in the form of another organisation. Members pay their dues directly to the National office. No dues are paid through the Branch.
- 5 Please refer to 4 above
- 6 The Branch has no secured funds, although in November 2002 the Division granted the Bond Branch \$500 for the purposes of mailing and refreshments at functions and since that time the money has been used for that purpose.
- 7 No financial records have been produced by the Branch.

8 The answer to question 8 is the major contributing factor in requesting an exemption. The Branches' membership is very small and still relatively inactive. BOND University does not allow the provision of union dues to be collected from members salaries, nor have they formally recognized the elected union officers. Until we can secure their employment and renew activism at this branch, we consider it to be prudent that the Division retains responsibility for any activity relating to the Branch and that the National Office continues to collect union dues.
