

S271A – Application for Certificate

My name is Matthew McGowan; I am the Victorian Division Secretary of the National Tertiary Education Union. I am making this application at the request of and on behalf of the Branch.

In consideration of s271A of the Act, I apply for a certificate to exempt the Branch from the requirements of the Act relating to financial matters occurring in the year ending 30 June 2002.

In support of the application I state:

- 1. The Branch does not hold an interest in any real or personal property.
- 2. The Branch does not act as a trustee in any form.
- 3. The Branch holds no funds prescribed under subrule 51.4 of the NTEU.
- 4. The Branch's structure is not mirrored in the form of another organisation.
- 5. Members pay their union dues individually by either direct debit or invoice to the National Office. No dues are paid through the Branch.
- 6. A small sustenance amount per member is remitted back to the Division Office, to be used if required for any activities on behalf of the members. The amount involved is less than \$100 per year.
- 7. The Branch does not have any obligations which require it to hold its own funds.
- 8. No financial records have been produced by the Branch for some years. No transactions were made after 1996. The Branch closed its bank account in June 1998 and transferred the remaining money to the Victorian Division.

9. The Branch's financial affairs are now, under subrule 40.A1, the responsibility of the Victorian Division and any expenditure is recorded through an imprest system and duly audited within the Division's own financial reports. The total amount held at 30 June 2002 is \$836.87 (See attach.)

Re: National Tertiary Education Industry Union-East Gippsland Institute of TAFE Branch Financial Reporting Obligations under *Workplace Relations Act 1996*

This is a courtesy letter to remind you of the financial reporting obligations of the abovenamed body under the *Workplace Relations Act 1996* ('the Act') for the financial year ended 30 June, 2002.

The legislative scheme set out in Part IX, Division 11 of the Act is directed at ensuring that a registered organisation or a branch of such an organisation discharges obligations of accountability to its members in relation to its financial affairs through proper and regular disclosure of financial information. The various steps of the financial reporting requirements must be carried out within the time-scales prescribed by the legislation so as to ensure the relevance of the financial information provided to the members.

Now that the financial year has ended, it is timely that you put in train the various steps of the financial reporting requirements. To assist you with this process I have enclosed for your information a notice summarising these requirements including the time-scales prescribed by the legislation.

Please note that a branch of an organisation may be exempted from the obligations arising under Part IX, Division 11 in respect of a financial year by satisfying a Registrar that the branch did not have any financial affairs during the financial year. An application under subsection 271A(1) of the Act must be made within 90 days (unless extended by a Registrar) after the end of the financial year.
