Re: Section 271 application for exemption from the financial reporting obligations of Part 3 of Chapter 8 of the *Fair Work (Registered Organisations) Act 2009* for financial years ended 30 June 2005 (FR2005/362) and 30 June 2006 (FR2006/283)

I refer to your letter of 13 April 2011 addressed to 'The Registrar' Fair Work Australia. The letter was received at Fair Work Australia on 21 April 2011.

In the correspondence you make application 'at the request of and on behalf of' the James Cook University of North Queensland Branch' (the Branch). I note that in support of the application you state that 'the Branch held no funds prescribed under sub rule 51.4 of the NTEU Rules', that 'no amounts were received or paid by the Branch as the Queensland State registered organization the James Cook University Staff Association acts as an agent for the collection and disbursements of the Union' and that 'the Branch does not have any obligations which require it to hold its own funds'.

I am satisfied that the Branch is a reporting unit and that it did not have any financial affairs in the years ended 30 June 2005 and 2006. The attached certificate reflects this decision.

I grant an extension of time for the making of the application(s). I do so, on the basis of the particular circumstances of this application.

I take this opportunity to remind you of the import of the reporting unit strictly complying with each aspect of the legislative reporting requirements under the *Fair Work (Registered Organisations) Act 2009*, the *Fair Work (Registered Organisations) Regulations 2009* and the Reporting Guidelines.

I advise the organisation that future applications must be made within 90 days after the end of the financial year.

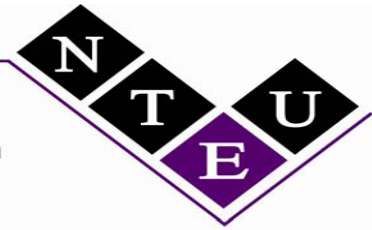
CERTIFICATE
