NOTES TO AND FORMING PART OF THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30TH JUNE 2002

1. STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

The financial statements consisting of Balance Sheet, Profit and Loss Statement and Revenue Statement are a special purpose financial report prepared in accordance with applicable Accounting Standard, and Urgent Issues Group Consensus Views.

The financial report is also prepared on an accruals basis and is based on historical costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following specific accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report:

Income Tax

No provision for Income Tax is necessary as "Trade Unions" are exempt from income tax under Section 23(f) of the Income Tax Assessment Act.

Property, Plant and Equipment

Property, plant and equipment are included at cost or independent valuation.

All assets, excluding freehold land and buildings are depreciated over the useful lives of the assets to the business.

Employee Entitlements

Provision is made for the liability for employee entitlements arising from services rendered by employees to balance date. Employee entitlements expected to be settled within one year together with entitlements arising from wages and salaries, annual leave and sick leave which will be settled after one year, have been measured at their nominal amount.

Contributions are made to an employee superannuation fund and are charged as expenses when incurred.

Re: FR2002/465 - Financial documents for year ended 30 June 2002

I have received the financial documents of the New South Wales Division of the National Tertiary Education Industry Union for the year ended 30 June 2002 lodged in the Industrial Registry on 20 December 2002.

The following matters concerning the financial reporting requirements of the Workplace Relations Act 1996 ('the Act') require your attention. Your written response to these matters is requested by 28 January 2003:

1. Auditor's Report.

The auditor in his report is required to give an opinion on the accounts and statements prepared under section 273 of the Act; such accounts include the certificates by the accounting officer and the committee of management. The dates of the certificates supplied in respect of your Division would indicate that they were prepared after the auditor made his report.

2. Copy of auditor's report and accounts to members.

Subsection 279(6) provides that members should be supplied with a copy of the signed auditor's report, the signed committee of management certificate and the signed accounting officer's certificate, together with a copy of the audited accounts at least 7 days before the meeting at which the report, certificates and accounts are to be presented - either a meeting of members or a meeting of the committee of management.

In your covering letter dated 13 December 2002, you state that the accounts were sent to the 'members as required by subsections 279(1) and (3)' of the Act. You also confirmed by phone on 6 January 2003 that you had ensured that sufficient time was allowed between mailing the accounts and holding the 'second meeting'.

Given that the committee of management certificate and accounting officer's certificate are both dated 29 November 2003 and that the financial documents were presented to the 'second meeting' on that date, it is unclear whether the documents have been supplied in accordance with subsections 279(1) and (3) and therefore whether the meeting of 29 November 2002 was sufficient for the purposes of 279(6) of the Act.

Would you please confirm that the documents have been supplied to members in accordance with subsections 279(1) and (3) and subsequently presented to a meeting in accordance with subsection 279(6).

It is noted that these requirements were brought to the attention of the Division for the period ending 30 June 2001 and, in your letter dated 27 June 2002 in relation to the 2001 Financial Returns, you stated:

"I now understand that in future they must be signed by me and relevant officers and the auditor before they are circulated to the members at least seven days before the meeting that approves them."

It is also noted that we requested a signed and dated copy of the auditor's report of the Division for the period ending 30 June 2001 - your letter dated 27 June 2002 indicated that it had been requested from the auditor. We have not yet received it. Would you please ensure that it is forwarded to this office as soon as practicable?
