I Kim Draisma being the President of the NTEU University of Wollongong Branch make this application.

In consideration of section 271 of the ACT, I apply for a certificate to exempt the Branch from the requirements of the Act relating to financial matters occurring in the years ending 2003, 2004, 2005 and 2006.

In support of the application I state:

1. The Branch did not hold an interest in any real or personal property;
2. The Branch does not act as a trustee in any form;
3. The Branch held no funds prescribed under sub rule 51.4 of the NTEU Rules (as that rule was in force until December 2007) or under Schedule G, Section 12(b);
4. All financial transactions were conducted through the Wollongong Academic Staff Association;
5. Members paid their union dues individually by payroll deduction, direct debit, credit card or invoice to the Wollongong Academic staff Association and the NTEU National Office;
6. The NTEU National Office directed that amount deemed to be the Branch fee to the Wollongong Academic Staff Association;



7. The Branch did not have any obligations which required it to hold its own funds;
8. The Branch's financial affairs under sub rule 40.A1 were the responsibility of the Wollongong Academic staff Association and the revenue was duly audited through the Wollongong Academic Staff Association financial reports.
