

Re: AR 2014/230 – Notification of Changes to Records s233(2) – Fair Work (Registered Organisations) Act 2009

I refer to the above, your correspondence dated 29 July 2014 and recent phone conversations with Assistant General Secretary Richardson.

As you are aware, the Union does not agree with your application of the relevant section of the Act.

For a considerable number of years the National Office and the branches of the Union have complied with s233 of the Act without the need to specify the occupation and/or postal address of officers elected or appointed in the periods between filing annual returns in March of each year.

Your reliance upon a policy infers a change of practise on the part of the Regulatory Compliance Branch in applying the relevant section.

The Union acknowledges that a change in policy as to the application of the Act may have occurred but believes that such change should be communicated to registered organisations in advance rather than require the redrafting and subsequent filing of amended or new declarations.

The information lodged provided advice to changes to persons holding offices as General President and General Secretary of the organisation and Branch Secretary and Assistant Branch Secretary of the Victorian Branch of the organisation.

I note the information lodged did not provide either the postal address or occupation of the persons listed as holding the above offices.

Section 233(1)(b) requires an organisation to lodge with the FWC each year, among other things, a copy of the records required to be kept under section 230(1)(c).

Section 233(2) requires an organisation to lodge within 35 days of any change to the records (regulation 151 of the Fair Work (Registered Organisations) Regulations 2009) required to be kept under section 230(1)(c).

As an organisation is required to keep and lodge annually with the FWC the names, addresses and occupations of persons holding office within the organisation, it is also required to notify the FWC of any change to that record, including changes to the name, address and occupation of an office holder.

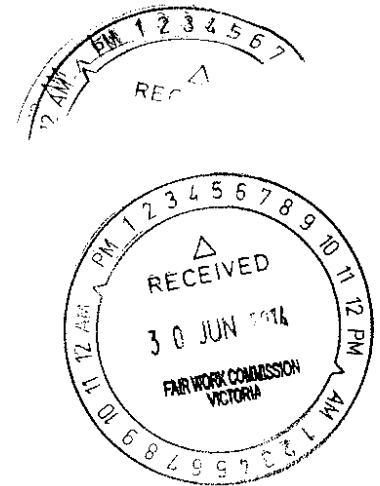

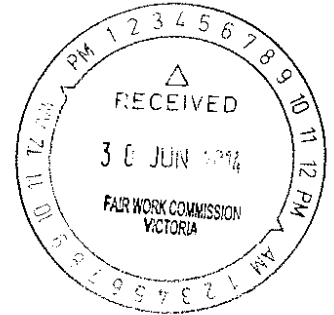

I acknowledge receipt on 31 March 2014 of your and Mr Roberts' Declarations and on 26 March 2014 of Mr Belan's and Mr Kennedy's Declarations providing information in accordance with subsection 233(1) of the *Fair Work (Registered Organisations) Act 2009* 'the RO Act'.

The documents lodged cover the required information for the 2014 Annual Return of Information of the National Union of Workers National Office and its General, New South Wales and Victorian Branches.

Organisation to lodge on behalf of all branches next year

Section 233 of the *Fair Work (Registered Organisations) Act 2009* requires an organisation to lodge a declaration and copies of information with the Fair Work Commission (the Commission) by the 31st March in each year. I note that in 2014 each branch of the National Union of Workers lodged a declaration and the required information. As section 233 places the onus of lodgement on the organisation and not each branch, it is the view of the Commission that the national body of the National Union of Workers is obliged to lodge all of the required information.

From 2015 the Commission intends to create one matter number for the National Union of Workers, instead of a matter number for each branch of National Union of Workers. From 2015 the national body of the National Union of Workers is requested to collate and lodge the information regarding the national body of the National Union of Workers and all of its branches. To assist with this task, I have attached a template annual return.

The annual returns for the National Office, General and Victorian Branches have been filed. In regard to the New South Wales Branch before the annual return can be filed receipt of the following information is required.

New South Wales Branch

Section 233 of the RO Act requires and organisation to lodge, among other information, a list of the names, postal addresses and occupations of person holding the offices. Attachment 2 to the annual return does not provide the offices which each office holder

holds. Would you please arrange lodgement of an amended list of office holders which provides the offices each Branch office holder holds.

The following matters are raised for your assistance in preparing future annual returns. No further action is required in relation to these.

Declaration

Section 233 of the RO Act requires declarations made in relation to an organisation's annual return of information to be certified by declaration signed by the secretary or other prescribed officer of the organisation to be a correct statement of the information contained in [records kept pursuant to section 230 of the Fair Work (Registered organisations) Act 2009]. Therefore please ensure that future annual returns and declarations of changes satisfy this requirement. Words to the effect of 'The information in this declaration is supplied in accordance with the provisions of the Fair Work (Registered Organisations) Act 2009 and is a correct statement of the records required to be kept under s230 of that Act' would satisfy this requirement.

I note this matter has been previously raised.
