

PRESCRIBED INFORMATION FOR CONDUCT OF ELECTION

A. The following information is in relation to an election that is to be conducted by the Australian Electoral Commission (“AEC”).

1. The name of each office or position for which an election is required. **[Regulation 139 (1) (a)]**

2. The reason for the election is as follows:
 - 2.1 Ara Frandi ceased to be eligible to be a member of the Union and accordingly resigned as a Committee of Management Member on 1 September 2014 before being able to assume office. **[Regulation 138 (1) (b) (ii)]**
 - 2.2 Alex Falconer resigned as National Council delegate on 1 October 2014. Pursuant to Rule 43 (3), the casual vacancy is filled by the Reserve National Council delegate, thus a casual vacancy for the nominated office exists. **[Regulation 138 (1) (b) (ii)]**
3. The number of offices or positions for each position is one. **[Regulation 138 (1) (c)].**
4. The electorate is the General Branch. **[Regulation 138 (1) (d)]**

5. The date and time of the beginning of the nomination period is the first working day nominated by the Australian Electoral Commission in accordance with Rules 13 (e) (5) and 43 (3). **[Regulation 138 (1) (e)]**
6. The date and time of the end of the nomination period is 12noon on the thirty first day after the commencement of the nomination period referred to at paragraph 5 above and in accordance with Rules 13 (e) (5) and 43 (3). **[Regulation 138 (1) (e)]**
7. The day upon which the roll of voters closes is seven days prior to the opening of nominations referred to in paragraph 5 above and in accordance with Rules 13 (e) (5) and 43 (3). **[Regulation 138 (1) (f)].**
8. The kind of voting is direct voting (i.e. first past the post"). **[Regulation 138 (1) (g)]**
