



Thank you for lodging this year's annual return.

In accordance with section 230(1)(d) of the *Fair Work (Registered Organisations) Act 2009* ("Act") an organisation must keep such other records as are prescribed.

For section 230(1)(d) of the Act, the following record is prescribed in relation to an organisation: a record of each election that must, under the rules of the organisation, be held during each year commencing 1 January for an office in the organisation and for an office in a branch of the organisation – see regulation 147(e) of the *Fair Work (Registered Organisations) Regulations 2009* ("Regulations").

Finally an organisation must lodge with FWA.....a copy of the records required to be kept under paragraph 230(1)(d), certified by declaration by the secretary of the organisation to be a correct statement of the information contained in that record – see section 233(1)(b) of the Act.

Please confirm via email if and when any of the offices of the NSW Branch will be up for election in the period 1 January 2010 – 31 December 2010. Please certify by declaration that the election information you provide is true and correct. You do not need to provide a statutory declaration.

The annual return is fine in all other respects and once we receive your email response we will be able to file the return.

Both the annual return and your email response will be published on the FWA website after filing.
