DECLARATION

I, Timothy John Kennedy, of 833 Bourke Street, Docklands Victoria, declare as follows:

1. I am the General Secretary of the National Union of Workers (“the Union”), an organisation of employees registered at the time under Schedule 1B of the Workplace Relations Act 1996 (“the RAO Schedule”) and I am authorised under the Rules of the Union to make this declaration.
2. This declaration is made in accordance with section 233 of the RAO Schedule and the accompanying Regulations.
3. Subject to the comments appearing in paragraphs 9 to 13 below, the following is a correct statement of the information contained in records to be kept by an organisation as required by the RAO Schedule
4. Based on the organisation’s records and to the best of my knowledge, I certify that a register of members of the Union was kept and maintained for the calendar year 2008 by the South Australian Branch (“the branch”) as required by sections 230 (1) (a) and 230 (2) of the RAO Schedule.
5. That Attachment 1 to this declaration is a list of the offices in the branch (section 230 (1) (b)).
6. That Attachment 2 to this declaration is a list of the names, postal addresses and occupations of the persons holding offices in the branch (section 230 (1) (c)).
7. That the address of the offices of the Union was 48 Greenhill Road, Wayville, South Australia 5034. (section 230 (1) (d) and regulation 147 (d)).

8. There were no elections under the rules of the Union required to be held during the year commencing 1 January 2009 (section 230 (1) (d) and regulation 147 (e).
9. In relation to requirements of s230 (1) (d) of the Act, I am unable with any precision to declare the number of members of the branch as at 31 December 2008.
10. The branch merged with several other branches of the Union with effect from 12 August 2009 [2009 FWAD 59 – R2009/1006].
11. The merged branches and the membership of the branches are now part of the General Branch of the Union.
12. Whilst the Union had and continues to have an integrated membership database it would be extremely time consuming and cost prohibitive for the Union to be able to extract the required data.
13. I note that in filing their annual financial records the branch declared it's membership as at 30 June 2008 as being 2613 [FR2008/242].
