The documents lodged cover the required information for the 2013 annual return of the National Union of Workers Victorian Branch.

I however note that section 233 requires declarations made in relation to an organisation's annual return of information to be 'certified by declaration signed by the secretary or other prescribed officer of the organisation to be a correct statement of the information contained in [records kept pursuant to section 230 of the Fair Work (Registered Organisations) Act 2009]'.
