

Annual Return of Information for 2014 [AR2014/92]

I acknowledge receipt on 26 March 2014 of your declaration providing information regarding The Pharmacy Guild of Australia (PGA) in accordance with subsection 233(1) of the *Fair Work (Registered Organisations) Act 2009* (the Act).

The matters addressed in your declaration meet the requirements of the Act and the Regulations for those elements.

However I draw to your attention the declarations with regard to the register of members by the respective Branches. The declarations regarding the New South Wales Branch and the South Australia Branch have been made by the respective Branch Director. This mirrors the information lodged in preceding years and the Fair Work Commission has not commented on this matter previously.

Under section 233(1)(a) of the Act the organisation must lodge “a declaration signed by the secretary or other prescribed officer of the organisation certifying that the register of members ...” has been kept. Although PGA rule 66(d)(ix) states that the duties of the Branch Director include “the maintenance of a register ...”, the Branch Director is not an elected office and so the declarations for New South Wales Branch and South Australia Branch do not properly meet the requirements of the Act.

The declarations are accepted for the 2014 Annual Return of Information but the return lodged in 2015 must ensure that the declarations are made by an appropriate officer for all branches.

Finally, I also acknowledge the Notification of Change of office holder dated 26 March 2014 in relation to the Australian Capital Territory Branch.
