1. A section 193 directions letter was sent to the candidate seeking an explanation. After reviewing the election results it was considered that the alleged irregularity did not affect the result of the election.

2. In NSW Branch the ballot period for the election of Committee Members was extended to provide voters who were inadvertently omitted from the original roll of voters the opportunity to vote.
