In compliance with the provisions of Section 189(1) and Regulation 138 of the RAO Schedule of the Workplace Relations Act 1996, The Pharmacy Guild of Australia submits the following information.

The National Office for which nominations will be called during the twelve month period commencing 1 January 2008 will be the office of National President (1).

Please note that the election for National Vice Presidents which previously was part of the National Elections will, from the 2008 Elections form part of the election for Branch President which will encompass the Branch President, National Councillor and National Vice President Positions. The Guild's Constitution has been amended to allow this election to take place.

The reason for the election is that the current term of office will expire in November 2008. In accordance with the Guild's Constitution, the following will occur:

- 1) If the number of candidates for this office number 2, the National President's election will be conducted under the direct voting system.
- 2) In the event that there are 3 or more candidates, the election will be conducted under a preferential voting system.

It is the wish of the Guild that the 2008 National President's election be conducted by the Australian Electoral Office. A copy of the proposed election timetable for the National President's election is appended thereto. The term of the office will be three years.

- Monday 25 August Councillors-elect Names are received by National Office from Branch Directors following announcement of results of Branch Elections.
- Thursday 28 August Returning Officer calls for nominations from National President from Councillors-elect.
- Thursday 11 September Nominations Close
- Friday 12 September If only one nomination is received to fill the position of National President, no election is required and the result can be announced by the Returning Officer although the National President-elect will not assume office until the National Council meeting in November.
- Monday 15 September If more than one nomination received for the office of National President, the Returning Officer shall distribute ballot papers and 'how to vote' instructions with pre-paid envelopes.
- Monday 29 September Ballot closes at 5pm.
- Tuesday 30 September Returning Officer counts ballot papers and announces result.

Finally on the first day of the November 2008 National Council meeting, the Returning Officer declares the official election result.

The term of office for the Guild Office Holders election in accordance with the foregoing will be three years.
