### Reminder of actions required when persons elected to office

The Australian Electoral Commission has provided the Registered Organisations Commission (the ROC) a declaration of results for the election of stages 1 and 2 uncontested offices for Victorian Branch [E2017/238]. This letter is a reminder of certain obligations imposed on organisations and on persons elected to office.

### A notice must be published on the organisation's website

The organisation or branch must publish on its website a notice that a copy of the report is available from the organisation, branch or the AEC on request. The notice must be kept on the website for a period of at least 3 months (see regulation 141 of the Fair Work (Registered Organisations) Regulations 2009).

### Holders of office required to undertake approved training

Section 293K of the *Fair Work (Registered Organisations) Act 2009* (the RO Act) requires each officer with financial management duties to undertake approved training that covers those duties within 6 months after the person begins to hold office. Please ensure that relevant officers undertake approved training within the required timeframe. Please also ensure that all new holders of office are advised of their obligations to make disclosures regarding remuneration, non-cash benefits and material personal interests, the details of which are provided for in the RO Act.

### Organisation must notify the Commission of changes

Also, section 233(2) of the RO Act requires that an organisation must notify the Commission within 35 days of any changes to the holders of office in the organisation. If there are no changes a notification is not required. If the election has resulted in any changes to the holders of office, the Pharmacy Guild of Australia, The must notify the Commission of these changes. In particular, please advise:

- 1. Person(s) who have ceased to hold office:
  - the name of the office vacated;
  - the date of the change of office holder; and
  - the name of the person vacating the office.
- 2. Person(s) who have commenced to hold office:
  - the name of the office now held;
  - the date of the change of office holder;

- the name of the person now holding the office;
- the postal address of the person (generally the postal address of the organisation); and
- the occupation of the person now holding the office.

The notification must include a declaration by the Secretary (or other prescribed officer) that the information is a correct statement of the changes made. A template notification of changes, which may assist you, is attached. If any change does not apply until a date in the future, you do not need to notify until then (e.g. AGM, 1 January, 2nd Monday in March). If you have already lodged this information, please disregard this reminder.

I, Timothy John Logan of Tim Logan's Nambour Pharmacy Shop 2-3 Nambour Central Mall, Lowe St, NAMBOUR QLD 4560, National Vice President, do solemnly and sincerely declare as follows:

- 1. I am a National Vice President of The Pharmacy Guild of Australia ('the Guild').
- 2. Nominations will be required to be called for the vacancies in the Branch Committee positions for District Number 8 and District Number 12 (2 positions) of The Pharmacy Guild of Australia VIC Branch. The reason for these elections is that insufficient nominations were received in the prior election (Election matter no. E2017/19).
- 3. Nominations will be required to be called for the vacancy in the position of Branch Vice President (1 position) of The Pharmacy Guild of Australia VIC Branch. The reason for this election is that insufficient nominations were received in the prior election (Election matter no. E2017/19).
- 4. A nomination will be required to be called for the vacancy in the position of Alternate National Councillor (1 position) of The Pharmacy Guild of Australia VIC Branch. The reason for this election is that George Tambassis, who was originally elected to the position of National Councillor (Election matter no. E2017/19), was subsequently elected to the position of National President (Election matter no. E2017/67). Grace Chong, who was elected as an Alternate National Councillor (Election matter no. 2017/19) and named as the first Alternate National Councillor by the VIC Branch Committee on 31 October 2017, fills the vacant position of National Councillor. This results in a vacancy for one of the positions of Alternate National Councillor.

In accordance with the Guild's Constitution the elections will be conducted under a direct voting system and I would be obliged if you arrange for the election to be conducted.
