Reminder of actions required when persons elected to office

The Australian Electoral Commission has provided the Registered Organisations Commission (the ROC) a declaration of results for the election of uncontested offices for National Branch [E2017/67]. This letter is a reminder of certain obligations imposed on organisations and on persons elected to office.

A notice must be published on the organisation's website

The organisation or branch must publish on its website a notice that a copy of the report is available from the organisation, branch or the AEC on request. The notice must be kept on the website for a period of at least 3 months (see regulation 141 of the Fair Work (Registered Organisations) Regulations 2009).

Holders of office required to undertake approved training

Section 293K of the *Fair Work (Registered Organisations) Act 2009* (the RO Act) requires each officer with financial management duties to undertake approved training that covers those duties within 6 months after the person begins to hold office. Please ensure that relevant officers undertake approved training within the required timeframe. Please also ensure that all new holders of office are advised of their obligations to make disclosures regarding remuneration, non-cash benefits and material personal interests, the details of which are provided for in the RO Act.

Organisation must notify the Commission of changes

Also, section 233(2) of the RO Act requires that an organisation must notify the Commission within 35 days of any changes to the holders of office in the organisation. If there are no changes a notification is not required. If the election has resulted in any changes to the holders of office, the Pharmacy Guild of Australia, The must notify the Commission of these changes. In particular, please advise:

- 1. Person(s) who have ceased to hold office:
 - the name of the office vacated;
 - the date of the change of office holder; and
 - the name of the person vacating the office.
- 2. Person(s) who have commenced to hold office:
 - the name of the office now held;
 - the date of the change of office holder;
 - the name of the person now holding the office;
 - the postal address of the person (generally the postal address of the organisation); and

• the occupation of the person now holding the office.

The notification must include a declaration by the Secretary (or other prescribed officer) that the information is a correct statement of the changes made. A template notification of changes, which may assist you, is attached. If any change does not apply until a date in the future, you do not need to notify until then (e.g. AGM, 1 January, 2nd Monday in March). If you have already lodged this information, please disregard this reminder.

Friday 8 September	Councillors-elect Names are received by National Office from Branch Directors following announcement of results of Branch Elections.	Branch
Friday 15 September	Returning Officer calls for nominations for National President from Councillors-elect.	AEC
Friday 29 September	Nominations Close	AEC
Friday 6 October	If only one nomination is received to fill the position of National President, no election is required and the result can be announced by the Returning Officer although the National President-elect will not assume office until the National Council meeting in November. (A nominee is entitled to withdraw their nomination within 7 days of the close of nominations)	AEC
Friday 20 October	If more than one nomination received for the office of National President, the Returning Officer shall distribute ballot papers and 'how to vote' instructions with pre-paid envelopes.	AEC
Friday 3 November	Ballot closes at 5pm.	AEC
Tuesday 7 November	Returning Officer counts ballot papers and announces result.	AEC

On the first day of the November 2017 National Council meeting, the National President is officially declared elected.
