I refer to your post-election report dated 21 September 2017.

I am aware that the AFPA is required to give a written response to the Report within 30 days of receipt of it, in accordance with Section 198 of the Fair Work (Registered Organisations) Act 2009 ('the RO Act').

I will ensure that the Report and this response to that Report will be provided to members by publication on the AFPA website for a minimum period of three months from the date of this letter. Additionally, a copy of the Report and response will be made available to the Registered Organisations Commissioner.

The report identified no matters relating to AFPA organisational rules.

The report identified matters relating to the approach of the AFPA in the allocation of members to a zone who may be working in another geographical location or in another role on a temporary basis.

The AFPA has determined that in such instances the member is allocated to the zone to which they are permanently assigned. Due to the majority of zones now being based on geographical location a member's relevant zone will be generally self-evident.

In the recent election, a member wrongly advised they were permanently attached to a different zone which required subsequent corrective action of which you are aware.

The AFPA has also established an executive committee to monitor the structure of zones and all related policy matters.

Reminder of actions required when persons elected to office

The Australian Electoral Commission has provided the Registered Organisations Commission (the ROC) a declaration of results for the election of uncontested and contested offices for Australian Federal Police Association Branch[E2017/51]. This letter is a reminder of certain obligations imposed on organisations and on persons elected to office.

A notice must be published on the organisation's website

The organisation or branch must publish on its website a notice that a copy of the report is available from the organisation, branch or the AEC on request. The notice must be kept on the website for a period of at least 3 months (see regulation 141 of the Fair Work (Registered Organisations) Regulations 2009).

Holders of office required to undertake approved training

Section 293K of the *Fair Work (Registered Organisations) Act 2009* (the RO Act) requires each officer with financial management duties to undertake approved training that covers those duties within 6 months after the person begins to hold office. Please ensure that relevant officers undertake approved training within the required timeframe. Please also ensure that all new holders of office are advised of their obligations to make disclosures regarding remuneration, non-cash benefits and material personal interests, the details of which are provided for in the RO Act.

Organisation must notify the Commission of changes

Also, section 233(2) of the RO Act requires that an organisation must notify the Commission **within 35 days of any changes** to the holders of office in the organisation. **If there are no changes a notification is not required.** If the election has resulted in **any changes** to the holders of office, the Police Federation of Australia-Australian Federal Police Association Branch must notify the Commission of these changes. In particular, please advise:

1. Person(s) who have ceased to hold office:
 - the name of the office vacated;
 - the date of the change of office holder; and
 - the name of the person vacating the office.

2. Person(s) who have commenced to hold office:
 - the name of the office now held;
 - the date of the change of office holder;
 - the name of the person now holding the office;
 - the postal address of the person (generally the postal address of the organisation); and

- the occupation of the person now holding the office.

The notification must include a declaration by the Secretary (or other prescribed officer) that the information is a correct statement of the changes made. A template notification of changes, which may assist you, is attached. If any change does not apply until a date in the future, you do not need to notify until then (e.g. AGM, 1 January, 2nd Monday in March). If you have already lodged this information, please disregard this reminder.

Other Matters

1. Membership to a particular Zone is dependent on what job/role/duties the member performs for the AFPA. This becomes an issue where the member is temporarily assigned to perform a different job/role/duties. The Association should identify how they will allocate Zone membership to these members – for example, do they continue to be a member of a Zone based on their permanent role, their temporary role, or their temporary role if that temporary role is for a <insert days/weeks/months/years> of time.

Example 1, is a candidate who is temporarily assigned to Zone B (but whose permanent position is in Zone A) entitled to be a candidate and a voter in Zone B? Is there a time limit to the temporary assignment that would make him/her qualify to be a candidate and a voter in Zone B?

Example 2, if a candidate has been temporarily assigned to Zone B for the last 2 years and would qualify (assuming example 1 above) but would only have 6 more months in the temporary assignment, can he/she qualify to be a candidate for the Schedule election (2 year term)? Noting that he/she may return to Zone A after 6 months and may not qualify to continue representing the Zone.

I, Adrian Graeme Smith, being the Secretary/Treasurer of, the Australian Federal Police Association Branch of the Police Federation of Australia, make the following statement:

1. I am authorised to sign this statement containing prescribed information for the Australian Federal Police Association Branch of the Police Federation of Australia (the Branch).
2. On 24 March 2017 I lodged with the Commission the statement required by subsection 189 (1) of the Fair Work (Registered Organisations) Act 2009 (Cth) (“the RO Act”) in respect of elections for Workplace Delegates under the Rules of the AFPA scheduled to commence on or about 1 June 2017 (“the 24 March Statement”). In paragraph 6 of the 24 March Statement I deposed that on 22 March 2017 the National Executive confirmed the adoption of a new set of Zones for those elections, and I attached as Annexure “A” the text of the National Executive Resolutions of that date and details of the new Zones.
3. I also deposed in the 24 March statement (at paragraph 8) that on 21 March 2017 the Branch National Council had adopted Rule changes which, inter alia, affected the Rules relating to the said elections, and that those Rule changes had been lodged with and were awaiting certification by the General Manager of the Fair Work Commission.
4. The Rule Changes referred to in Paragraph 8 of the 24 March Statement and paragraph 3 of this Statement were certified by the General Manager on 25 May 2017.
5. In consequence of the certification of the said rule changes, and as foreshadowed in the 24 March Statement, I now submit this Supplementary Statement pursuant to sub section 189 (1) of the RO Act. This Supplementary statement is to be read in conjunction with the 24 March Statement.
6. The contents of Annexures “A”, “B”, and “C” to this Statement entirely replace the contents of Annexures “B” and “C” to the 24 March Statement.
7. The Zones are set out in the table in Annexure A.
8. The offices for which an election is required are set out in Annexure B as are the reason for the election, the number of persons to be elected, the electorate and the manner of election.
9. A table setting out the number of members within each Zone is included at Annexure C.

10. The number of Zone Workplace Delegate/Delegate to National Council entitled to represent each Zone is set according to the number of members within that Zone, based on a formula set out in Rule 95 (2) (c) and 72 (3).

7. The offices for which an election is required are set out in Annexure B as are the reason for the election, the number of persons to be elected, the electorate and the manner of election.
8. On 21 March 2017, the Branch National Council approved rule changes AND the proposed rules are awaiting certification by the General Manager, Fair Work Commission. An amended notification will be supplied upon certification of the rules, however, the proposed changes will only have 2 effects, as indicated in parentheses “()” in Annexure B, for current purposes:
 - 8.1 Alter the number of the relevant Zone Election Rule from 96 to 95; and
 - 8.2 The title “Zone Coordinator” shall become “Zone Convenor”
9. The number of Zone Workplace Delegate/Delegate to National Council entitled to represent each Zone is set according to the number of members within that Zone, based on a formula set out in Rule 66(b)(i). A table setting out the number of members within each Zone is set out in Annexure C.

ANNEXURE A

This National Executive, notes that:

- i. On 23 February 2017, the National Executive resolved pursuant to Rule 90 to adopt, in principle, a new Zone system for the election of delegates to the National Council for elections scheduled to commence on or about 1 June 2017 pursuant to the Rules relating to elections in the AFPA;
- ii. The basis of the new Zone system is that, unless a member is assigned to one of 6 designated work divisions (being community policing, Intel Canberra, SRG, Forensics, PSO or Executive and International) that member will be allocated to the zone representing the State or Territory in which that member resides or is stationed; and
- iii. The National Council endorsed the proposed new Zone system at its meeting on 21 March 2017.

The National Executive hereby resolves:

1. The Zones for the election of workplace delegates adopted by the National Executive on 11 May 2015 are hereby abolished from the date of the declaration of the election of delegates for Zones scheduled to commence on 1 June 2017, being approximately 15 August 2017, but to avoid doubt without prejudice to the continuation of any office arising from the zone elections declared in November 2016 to that time;
2. The Zones for the elections of workplace delegates from 2017 onwards shall be:
 - Community Policing
 - New South Wales
 - Victoria/Tasmania
 - Queensland
 - South Australia
 - West Australia
 - Canberra
 - Northern Territory
 - Intelligence Canberra
 - Forensics
 - Specialist Response Group
 - Protective Service Officers
 - Executive and International
3. A member will be allocated to any such Zone based on either the location of his or her place or station of deployment, or specific area of work assignment, as specified in the table of Zones circulated to National Executive members with this proposed resolution and identified with the letter "A"; and
4. To avoid doubt the right of a member to vote in, nominate as a candidate for or nominate another member as a candidate for any Zone election following the adoption of this resolution will depend upon the zone to which that member is allocated pursuant to this resolution as at the date of calling of nominations for elections in that zone.
