
STATUTORY DECLARATION

I acknowledge receipt of statutory declaration of Bruce McKenzie of the Victorian Branch of the organisation declared on 18 February 2003. I should point out that the statutory declaration should have been signed by an officer of the branch. I appreciate this office has accepted statutory declarations signed by Mr McKenzie in the past, however subsections 268(3)(a) and (b) of the Act require the lodgement of a statutory declaration by the Secretary or other prescribed officer. "Office" is defined under section 4 of the Act as an office of a voting member of a collective body of the organisation or branch, being a collective body that has power in relation to certain functions described in section 4. It would appear from the rules that the duties of 'Assistant Secretary (Administration Support)' are such that would not bring the position into line with the definition of "office" appearing in the Act. I look forward to receiving a new statutory declaration signed by an officer of the branch.

I would also be pleased to receive election information for the NSW branch which was omitted from the statutory declaration.

I would also be pleased to receive the addresses of the offices of the Northern Territory and New South Wales branches which is also required to be lodged under s.268 of the *Workplace Relations Act 1996*.

I look forward to receiving the requested information as well as the return for the Australian Federal Police Association Branch.

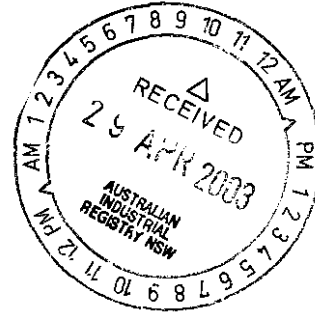


