Re: Police Federation of Australia and all Branches Annual Return of information contained in records kept by organisation – AR 2011/2507, 2503, 2504, 2506, 2508 & 2696

I have received your declarations dated 23 March 2011 providing information in accordance with subsection 233(1) of the *Fair Work (Registered Organisations) Act 2009* (the Act). The documents were lodged with Fair Work Australia (FWA) on 24 March 2011.

The documents lodged cover the required information for the **2011** Annual Return of the organisation and branches.

The above return contained changes to holders of office that occurred in 2010. Section 233(2) of the Act requires:

'an organisation must, within the prescribed period, lodge in with FWA notification of any change made to the records required to be kept under paragraphs 230(1)(b), (c) and (d), certified by declaration signed by the secretary or other prescribed officer of the organisation to be a correct statement of the changes made.'
