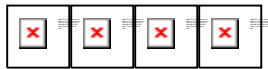

**Notification of changes made to records [AR2015/53] - Australian Federal Police Branch of the Police Federation of Australia**

I am writing in relation to your letter to Mr. Mark Burgess, the CEO of the Police Federation of Australia (PFA) dated 4 December 2015, who presented your letter to me as evidence that Ms. Smith's appointment is legitimate. I would like to provide the current status of the appointment so as to respectfully request your reconsideration in relation to the record of the Fair Work Commission.

As the elected CEO of the Australian Federal Police Association (AFPA) branch of the PFA, I was surprised to learn the Notification of Change had been made by Mr Ian Bridle through Mr Punch of Carroll O'Dea Solicitors without my knowledge.

I am further surprised that Mr Burgess has been involved during the process which, as you may be aware, under Rule 35 of the PFA, the AFPA is an autonomous operating branch of the Federation as are the other branches. The affairs of the Branch are the sole responsibility of the Branch including its administration, election/appointment of office holder and so forth.

The background

The Association is undergoing a federal court inquiry in relation to potential irregularities occurred during delegation election in July 2015, which I had written to the AEC and FWC to advise of irregularities and request a stay. The members of the NE, including then president JHS, and I have separate legal representation. Mr Punch is representing the members of the NE in that Federal Court Inquiry

As of 26 October 2015, the former President Mr Jon Hunt-Sharman resigned from the AFPA, effective from 9 November 2015.

Without any prior discussion with other members of the Branch National Council (BNC), who under the Rule 73(d)(i)(a) also are entitled to be considered for appointment, on 11 November 2015, 4 members of Branch National Executive (four voting members), convened and appointed Ms Smith as the replacement AFPA President.

Members of the BNC have since questioned the legitimacy of the appointment under the Rules.

As the CEO of the Association, I subsequently sought a legal advice in relation to the appointment and circumstances surrounding the appointment. According to legal advice received on 26 August 2015 and 24 November 2015 (Attached) It is understood that the meeting on 11 November 2015 and the appointment made during that meeting is invalid under AFPA Branch Rule 77(b).

I have since notified the members of BNE and advised that the error will need to be rectified at a later validly convened meeting according to the Rules.

It is my understanding that Mr Ian Bridle wrote to you to advise of the 'appointment'. Mr Bridle is ordinarily an elected Branch Vice President without any AFPA duties other than those afforded under the Rules for Vice Presidents and the Branch National Executive. Mr Bridle currently is a full time employee of the Australian Federal Police.

I also understand that the BNE made a resolution that Mr Bridle assume a responsibility of the CEO under Rule 80 specifically for the purpose of writing to FWC to advise of the appointment of Ms Smith. That is a function of the duly elected CEO. However, the legal advice that I received from an external barrister is of opinion that resolution is invalid for the same reason as above.

Whilst it is regrettable the AFPA is struggling with internal division, it is my intention that appointment, election and all other obligations of the Branch under the Act are met in accordance with the Rules.

As stated, the clear advice to me regarding the circumstances indicates that the appointment was not validly made and we have not yet been able to arrive at a way forward on this matter.

I feel I am obliged to inform you of these circumstances in the event they were not made clear, and I am willing to discuss the matter further and seek the advice of the Fair Work Commission.
