

### **Annual Return of Information for 2016 [AR2016/53]**

I acknowledge receipt on 30 March 2016 of your Declaration providing information in accordance with subsection 233(1) of the *Fair Work (Registered Organisations) Act 2009* (the RO Act).

The documents lodged cover most of the required information for the 2016 Annual Return of Information of the Police Federation of Australia. The material has been filed and can be viewed on the Fair Work Commission website through the List of Registered Organisations - <http://www.fwc.gov.au/index.cfm?pagename=regorgslist> .

I make the following comments to assist with future lodgements.

First, the material provided by Mr Sycz of your Queensland Police Branch was not signed or dated. Could you please arrange for Mr Sycz to lodge a signed, dated declaration.

Secondly, street addresses have been provided in connection with the list of offices for various Branches. Subsections 230(1)(c) and 233(1)(b) of the RO Act instead require you to keep and lodge a true statement of, inter alia, "a list of the names, *postal* addresses and occupations of the persons holding the offices;"
